A BILL TO BE ENTITLED
AN ACT

1 To amend an Act to provide a new charter for the City of Atlanta, approved April 15, 1996
2 (Ga. L. 1996, p. 4469), as amended, so as to change the corporate limits of such municipality;
3 to provide for related matters; to repeal conflicting laws; and for other purposes.

4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

5 **SECTION 1.**

6 An Act to provide a new charter for the City of Atlanta, approved April 15, 1996
7 (Ga. L. 1996, p. 4469), as amended, is amended by designating the current text of
8 Section 1-105 as subsection (a) and by adding a new subsection (b) to read as follows:

9 "(b) In addition to the territory described in subsection (a) of this section, the corporate
10 boundaries of the City of Atlanta shall also include all of the unincorporated territory of
11 Fulton County on the effective date of this Act north of the centerline of the right of way
12 of State Route 402, also known as Interstate 20, less and except the Fulton County
13 Airport-Brown Field more particularly described as follows:

14 BEGINNING in Land Lot 17 of the 14th District F.F., at the intersection of Sandy
15 Creek Road and the northwesterly right-of-way of Fulton Industrial Boulevard; thence
16 proceeding southwesterly along said right-of-way to the point of intersection with the

17 corporate limit line of the City of Atlanta, Georgia, said corporate limit line being the
18 eastern line of Land Lot 22, 14th District F.F., Fulton County, Georgia; thence
19 southerly along said corporate limit line to a point of the east line of Land Lot 23, 1,140
20 feet, more or less north of the southeast corner of said land lot; thence northwesterly to
21 a point at the southeast right-of-way intersection of Martin Luther King Jr. Dr. SW and
22 Fulton Industrial Boulevard SW; thence continuing northwesterly along the south
23 right-of-way of Martin Luther King Jr. Drive SW to a point of intersection between the
24 Fulton County Line and the southern right-of-way of Martin Luther King Jr. Dr. SW
25 said County line also lying in the Chattahoochee River and being the western line of
26 Land Lot 53 of the 14th District F.F, in said County and State; thence north and east
27 with the Fulton County line to the northwest corner of Charlie Brown County Airport
28 at the intersection of Sandy Creek and the Chattahoochee River, said point being in
29 Land Lot 20, 14'h District F.F. of said County and State; thence, running along Sandy
30 Creek south and east to a point of intersection with the southern line of Land Lot 20;
31 thence, proceeding along the southern line of Land Lot 20 in an easterly direction to the
32 southeast corner of Land Lot 18, said point being on the District Line between the 14th
33 District F.F. and the 17th District; thence, along said western District Line of the 17"
34 District in a southerly direction 1,410 feet, more or less of the northern right-of-way of
35 Sandy Creek Road; thence, in a westerly direction 2,500 feet, more or less to a fence
36 corner on the southwest right-of-way of Fulton Industrial Boulevard to the said point
37 of BEGINNING."

38 **SECTION 2.**

39 All laws and parts of laws in conflict with this Act are repealed.
