A RESOLUTION

1 Recognizing and commending Patricia Gant; and for other purposes.

2 WHEREAS, Patricia Gant has long been recognized by the citizens of this state for the vital
3 role that she has played in leadership and her deep personal commitment to the welfare of
4 the citizens of Georgia; and

5 WHEREAS, with the ultimate goal of empowering and encouraging the less fortunate, she
6 co-founded Feeding Accepting Inspiring The Hurting (F.A.I.T.H.), a nonprofit organization
7 that focuses on feeding the hungry, clothing the naked, and giving financial assistance to the
8 needy; and

10 talents, and energy toward the betterment of her community through her superlative service

16 sanitizer needs; and more; and

18 during the pandemic to provide struggling citizens with financial assistance; and

19 WHEREAS, this distinguished gentlewoman has given inspiration to many through her high
20 ideals, morals, and deep concern for her fellow citizens, and she possesses the vast wisdom
21 which only comes through experience and the strength of character which is achieved
22 through overcoming the many challenges of life; and

23 WHEREAS, she is a person of magnanimous strengths with an unimpeachable reputation for
24 integrity, intelligence, fairness, and kindness; and

25 WHEREAS, Patricia Gant has served with honor and distinction with F.A.I.T.H., and her
