A BILL TO BE ENTITLED
AN ACT

1 To amend Chapter 1 of Title 43 of the Official Code of Georgia Annotated, relating to
2 general provisions of professions and businesses, so as to change certain provisions relating
3 to expedited license by endorsement for military spouses; to provide for related matters; to
4 provide for an effective date; to repeal conflicting laws; and for other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 Chapter 1 of Title 43 of the Official Code of Georgia Annotated, relating to general
8 provisions of professions and businesses, is amended by revising Code Section 43-1-34.1,
9 relating to expedited license by endorsement for military spouses, as follows:

10 "43-1-34.1.

11 (a) As used in this Code section, the term:

12 (1) 'License' shall have the same meaning as provided in Code Section 43-1-34.

13 ~~(2) 'Military' shall have the same meaning as provided in Code Section 43-1-34.~~

14 ~~(3)~~(2) 'Other board' shall have the same meaning as provided in Code Section 43-1-34.

15 ~~(4)~~(3) 'Service member' shall have the same meaning as provided in Code Section

17 ~~(5)~~(4) 'State' means a state of the United States, the District of Columbia, Puerto Rico,
18 the United States Virgin Islands, or any territory or insular possession subject to the
19 jurisdiction of the United States.

20 ~~(6)~~(5) 'Transitioning service member' shall have the same meaning as provided in Code
21 Section 43-1-34.

22 (b) Notwithstanding any other provisions of law, a professional licensing board or other
23 board shall issue an expedited license by endorsement to any individual ~~that~~ who:

24 (1) Is a spouse of a service member or transitioning service member stationed within ~~this~~
25 ~~state~~ the State of Georgia;

26 (2) Holds a current license to practice such occupation or profession issued by another
27 state ~~for which the training, experience, and testing are substantially similar in~~
28 ~~qualifications and scope to the requirements under this state to obtain a license; and~~

29 (3) Is in good standing in such other state; ~~and~~

30 ~~(4) Passes any examination that may only be required to demonstrate knowledge of the~~
31 ~~laws and rules and regulations of this state specific to the practice of the profession,~~
32 ~~business, or trade for which such expedited license by endorsement is being sought.~~

33 (c) An expedited license by endorsement provided for under subsection (b) of this Code
34 section shall be issued within 30 days of receipt of an application. Such application shall
35 only require the minimum amount of information and documentation necessary to ensure
36 that the applicant meets the requirements set forth in subsection (b) of this Code section.

37 ~~(c)~~(d) Nothing contained in this Code section shall be construed to invalidate, override, or
38 amend any licensing compact entered into by the State of Georgia."

39 **SECTION 2.**

40 This Act shall become effective upon its approval by the Governor or upon its becoming law
41 without such approval.

43 All laws and parts of laws in conflict with this Act are repealed.
