

House Bill 1077

A BILL TO BE ENTITLED

AN ACT

1 To amend an Act providing for the Board of Education of Thomas County, approved
2 March 30, 1989 (Ga. L. 1989, p. 4321), as amended, particularly by an Act approved
3 February 15, 2012 (Ga. L. 2012, p. 3501), so as to change the description of the education
4 districts; to provide for definitions and inclusions; to provide for effective dates; to repeal
5 conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 An Act providing for the Board of Education of Thomas County, approved March 30, 1989
9 (Ga. L. 1989, p. 4321), as amended, particularly by an Act approved February 15, 2012 (Ga.
10 L. 2012, p. 3501), is amended by striking subsections (a) and (b) of Section 2 of said Act and
11 inserting in their place the following:

12 "(a) The Board of Education of Thomas County shall consist of seven members. For
13 purposes of electing members of the board of education, the Thomas County School
14 District is divided into seven education districts. The seven education districts shall be and
15 correspond to those seven numbered districts described in Appendix A attached to and

made a part of this Act and further identified as 'User: Thomas SB Plan Name: ThomasSB-2022 Plan Type: Local'.

(b)(1) For the purposes of such plan:

(A) The term 'VTD' shall mean and describe the same geographical boundaries as provided in the report of the Bureau of the Census for the United States decennial census of 2020 for the State of Georgia. The separate numeric designations in a district description which are underneath a VTD heading shall mean and describe individual Blocks within a VTD as provided in the report of the Bureau of the Census for the United States decennial census of 2020 for the State of Georgia; and

(B) Except as otherwise provided in the description of any district, whenever the description of any district refers to a named city, it shall mean the geographical boundaries of that city as shown on the census maps for the United States decennial census of 2020 for the State of Georgia.

(2) Any part of the Thomas County School District which is not included in any district described in subsection (a) of this section shall be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2020 for the State of Georgia.

(3) Any part of the Thomas County School District which is described in subsection (a) of this section as being included in a particular district shall nevertheless not be included within such district if such part is not contiguous to such district. Such noncontiguous part shall instead be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2020 for the State of Georgia."

SECTION 2.

(a) Those members of the Board of Education of Thomas County who are serving as such on the effective date of this Act and any person selected to fill a vacancy in any such office

42 shall continue to serve as such members until the regular expiration of their respective terms
43 of office and upon the election and qualification of their respective successors.

44 (b) Districts 1, 2, 3, 4, 5, 6, and 7, as they exist immediately prior to the effective date of this
45 Act, shall continue to be designated as Districts 1, 2, 3, 4, 5, 6, and 7, respectively, but as
46 newly described under this Act, and on and after the effective date of this Act, such members
47 of the board serving from those former districts shall be deemed to be serving from and
48 representing their respective districts as newly described under this Act.

49 **SECTION 3.**

50 The provisions of this Act necessary to conduct elections for the members of the Board of
51 Education of Thomas County in 2022 shall become effective upon the approval of this Act
52 by the Governor or upon its becoming law without such approval. The remaining provisions
53 of this Act shall become effective on January 1, 2023.

54 **SECTION 4.**

55 All laws and parts of laws in conflict with this Act are repealed.
