**AS PASSED SENATE**

A BILL TO BE ENTITLED

AN ACT

1 To amend an Act to reconstitute the Meriwether County Board of Education, approved  
2 March 28, 1985 (Ga. L. 1985, p. 4611), as amended, so as to change the description of the  
3 education districts; to provide for definitions and inclusions; to provide for continuation in  
4 office of current members; to provide for related matters; to provide effective dates; to repeal  
5 conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 An Act to reconstitute the Meriwether County Board of Education, approved March 28, 1985  
9 (Ga. L. 1985, p. 4611), as amended, is amended by revising Section 4 as follows:

10 "SECTION 4.

11 (a) For the purpose of electing members of the Board of Education of Meriwether County,  
12 the Meriwether County School District is divided into five districts. Such districts shall be  
13 and correspond to those five numbered districts described in Appendix A attached to and  
14 made a part of this Act and further identified as 'User: Meriwether Plan Name:  
15 MeriwetherCCSB-2022 Plan Type: Local'.

16 (b)(1) For the purposes of such plan:

17 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
18 provided in the report of the Bureau of the Census for the United States decennial  
19 census of 2020 for the State of Georgia. The separate numeric designations in a district  
20 description which are underneath a VTD heading shall mean and describe individual  
21 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
22 United States decennial census of 2020 for the State of Georgia; and

23 (B) Except as otherwise provided in the description of any district, whenever the  
24 description of any district refers to a named city, it shall mean the geographical  
25 boundaries of that city as shown on the census maps for the United States decennial  
26 census of 2020 for the State of Georgia.

27 (2) Any part of the Meriwether County School District which is not included in any  
28 district described in subsection (a) of this section shall be included within that district  
29 contiguous to such part which contains the least population according to the United States  
30 decennial census of 2020 for the State of Georgia.

31 (3) Any part of the Meriwether County School District which is described in  
32 subsection (a) of this section as being included in a particular district shall nevertheless  
33 not be included within such district if such part is not contiguous to such district. Such  
34 noncontiguous part shall instead be included within that district contiguous to such part  
35 which contains the least population according to the United States decennial census  
36 of 2020 for the State of Georgia."

## **SECTION 2.**

38 (a) Those members of the Board of Education of Meriwether County who are serving as  
39 such on the effective date of this Act and any person selected to fill a vacancy in any such  
40 office shall continue to serve as such members until the regular expiration of their respective  
41 terms of office and upon the election and qualification of their respective successors.

42 (b) Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective date of this Act,  
43 shall continue to be designated as Districts 1, 2, 3, 4, and 5, respectively, but as newly  
44 described under this Act, and on and after the effective date of this Act, such members of the  
45 board serving from those former districts shall be deemed to be serving from and  
46 representing their respective districts as newly described under this Act.

47

**SECTION 3.**

48 The provisions of this Act necessary to conduct elections for the members of the Board of  
49 Education of Meriwether County in 2022 shall become effective upon the approval of this  
50 Act by the Governor or upon its becoming law without such approval. The remaining  
51 provisions of this Act shall become effective on January 1, 2023.

**SECTION 4.**

53 All laws and parts of laws in conflict with this Act are repealed.
