A BILL TO BE ENTITLED

AN ACT

1 To amend an Act to amend, restate, revise, reorganize, and modernize the law relating to the  
2 Board of Commissioners of Camden County, approved March 25, 2002 (Ga. L. 2002,  
3 p. 3609), as amended, particularly by an Act approved March 5, 2012 (Ga. L. 2012, p. 3963),  
4 so as to change the description of the commissioner districts; to provide for definitions and  
5 inclusions; to provide for continuation in office of current members; to provide for effective  
6 dates; to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act to amend, restate, revise, reorganize, and modernize the law relating to the Board of  
10 Commissioners of Camden County, approved March 25, 2002 (Ga. L. 2002, p. 3609), as  
11 amended, particularly by an Act approved March 5, 2012 (Ga. L. 2012, p. 3963), is amended  
12 by revising Section 2 as follows:

13 "SECTION 2.

14 (a) For purposes of electing members of the board of commissioners, Camden County  
15 shall be divided into five commissioner districts. One member of the board shall be elected

16 from each such district. Commissioner districts 1, 2, 3, 4, and 5 shall be and correspond  
17 to those five numbered districts described in Appendix A attached to and made a part of  
18 this Act and further identified as 'User: Camden Co. Plan Name: CamdenCCSB-2022 Plan  
19 Type: Local'.

20 (b)(1) For the purposes of such plan:

21 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
22 provided in the report of the Bureau of the Census for the United States decennial  
23 census of 2020 for the State of Georgia. The separate numeric designations in a district  
24 description which are underneath a VTD heading shall mean and describe individual  
25 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
26 United States decennial census of 2020 for the State of Georgia; and

27 (B) Except as otherwise provided in the description of any district, whenever the  
28 description of any district refers to a named city, it shall mean the geographical  
29 boundaries of that city as shown on the census maps for the United States decennial  
30 census of 2020 for the State of Georgia.

31 (2) Any part of Camden County which is not included in any district described in  
32 subsection (a) of this section shall be included within that district contiguous to such part  
33 which contains the least population according to the United States decennial census of  
34 2020 for the State of Georgia.

35 (3) Any part of Camden County which is described in subsection (a) of this section as  
36 being included in a particular district shall nevertheless not be included within such  
37 district if such part is not contiguous to such district. Such noncontiguous part shall  
38 instead be included within that district contiguous to such part which contains the least  
39 population according to the United States decennial census of 2020 for the State of  
40 Georgia.

41 (c) Commissioner districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective  
42 date of this Act, shall continue to be designated as commissioner districts 1, 2, 3, 4, and 5,

43 respectively, but as newly described under this Act, and on and after the effective date of  
44 this Act, such members of the board serving from those former commissioner districts shall  
45 be deemed to be serving from and representing their respective districts as newly described  
46 under this Act.”

47 **SECTION 2.**

48 Those members of the Board of Commissioners of Camden County who are serving as such  
49 on the effective date of this Act and any person selected to fill a vacancy in any such office  
50 shall continue to serve as such members until the regular expiration of their respective terms  
51 of office and upon the election and qualification of their respective successors.

52 **SECTION 3.**

53 The provisions of this Act necessary to conduct elections for the members of the Board of  
54 Commissioners of Camden County in 2022 shall become effective upon the approval of this  
55 Act by the Governor or upon its becoming law without such approval. The remaining  
56 provisions of this Act shall become effective on January 1, 2023.

57 **SECTION 4.**

58 All laws and parts of laws in conflict with this Act are repealed.
