

House Bill 1251

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act providing for the composition and election of the Board of Education of  
2 Emanuel County, approved April 12, 1982 (Ga. L. 1982, p. 4049), as amended, particularly  
3 by an Act approved May 2, 2017 (Ga. L. 2017, p. 3599), so as to change the description of  
4 the education districts; to provide for definitions and inclusions; to provide for continuation  
5 in office of current members; to provide for election and terms of office of subsequent  
6 members; to provide for effective dates; to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act providing for the composition and election of the Board of Education of Emanuel  
10 County, approved April 12, 1982 (Ga. L. 1982, p. 4049), as amended, particularly by an Act  
11 approved May 2, 2017 (Ga. L. 2017, p. 3599), is amended by revising Section 1 as follows:

12 "SECTION 1.

13 (a) The Board of Education of Emanuel County shall consist of seven members, all of  
14 whom shall be elected from education districts described in subsection (b) of this section.

15 (b) For purposes of electing members of the board of education, the Emanuel County  
16 School District is divided into seven education districts. The seven education districts shall  
17 be and correspond to those seven numbered districts described in Appendix A attached to  
18 and made a part of this Act and further identified as 'User: Emanuel SB Plan Name:  
19 EmanuelSB-2022 Plan Type: Local'.

20 (c)(1) For the purposes of such plan:

21 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
22 provided in the report of the Bureau of the Census for the United States decennial  
23 census of 2020 for the State of Georgia. The separate numeric designations in a district  
24 description which are underneath a VTD heading shall mean and describe individual  
25 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
26 United States decennial census of 2020 for the State of Georgia; and

27 (B) Except as otherwise provided in the description of any district, whenever the  
28 description of any district refers to a named city, it shall mean the geographical  
29 boundaries of that city as shown on the census maps for the United States decennial  
30 census of 2020 for the State of Georgia.

31 (2) Any part of the Emanuel County School District which is not included in any district  
32 described in subsection (b) of this section shall be included within that district contiguous  
33 to such part which contains the least population according to the United States decennial  
34 census of 2020 for the State of Georgia.

35 (3) Any part of the Emanuel County School District which is described in subsection (b)  
36 of this section as being included in a particular district shall nevertheless not be included  
37 within such district if such part is not contiguous to such district. Such noncontiguous  
38 part shall instead be included within that district contiguous to such part which contains  
39 the least population according to the United States decennial census of 2020 for the State  
40 of Georgia."

41 **SECTION 2.**

42 Said Act is further amended by striking in its entirety the attachment thereto containing the  
43 descriptions of the seven education districts which is identified as 'Plan:  
44 emansb-court-p1-2016 Plan Type: Local Administrator: Emanuel SB User: Gina'.

45 **SECTION 3.**

46 (a) All members of the board of education serving in office on the effective date of this Act  
47 shall continue to serve until the expiration of the terms for which they were elected and until  
48 their respective successors are elected and qualified unless otherwise removed from office  
49 as provided by the Constitution and laws of this state.

50 (b) Education Districts 1 through 7, as they exist immediately prior to the effective date of  
51 this section, shall continue to be designated as Education Districts 1 through 7, respectively,  
52 but as newly described under this section, and on and after the effective date of this section,  
53 such members of the board serving from those former education districts shall be deemed to  
54 be serving from and representing their respective districts as newly described under this  
55 section.

56 **SECTION 4.**

57 The provisions of this Act necessary to conduct elections for the members of the board  
58 in 2022 shall become effective upon the approval of this Act by the Governor or upon its  
59 becoming law without such approval. The remaining provisions of this Act shall become  
60 effective on January 1, 2023.

61 **SECTION 5.**

62 All laws and parts of laws in conflict with this Act are repealed.
