A BILL TO BE ENTITLED
AN ACT

1 To amend an Act providing for the election of members of the board of education of
2 Chattooga County, approved April 25, 2002 (Ga. L. 2002, p. 4723), as amended, so as to
3 change the description of the education districts; to provide for definitions and inclusions;
4 to provide for continuation in office of current members; to provide for related matters; to
5 provide for effective dates; to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 An Act providing for the election of members of the board of education of Chattooga
9 County, approved April 25, 2002 (Ga. L. 2002, p. 4723), as amended, is amended by revising
10 Section 1 as follows:

11 "SECTION 1.

12 (a) For the purpose of electing members of the board of education of Chattooga County,
13 the Chattooga County School District shall be divided into five education districts. The
14 districts shall be and correspond to those five numbered districts described in Appendix A

15 attached to and made a part of this Act and further identified as 'User: Chattooga SB Plan
16 Name: ChattoogaSB-2022 Plan Type: Local'.

17 (b)(1) For the purposes of such plan:

18 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
19 provided in the report of the Bureau of the Census for the United States decennial
20 census of 2020 for the State of Georgia. The separate numeric designations in a district
21 description which are underneath a VTD heading shall mean and describe individual
22 Blocks within a VTD as provided in the report of the Bureau of the Census for the
23 United States decennial census of 2020 for the State of Georgia; and

24 (B) Except as otherwise provided in the description of any district, whenever the
25 description of any district refers to a named city, it shall mean the geographical
26 boundaries of that city as shown on the census maps for the United States decennial
27 census of 2020 for the State of Georgia.

28 (2) Any part of the Chattooga County School District which is not included in any
29 district described in subsection (a) of this section shall be included within that district
30 contiguous to such part which contains the least population according to the United States
31 decennial census of 2020 for the State of Georgia.

32 (3) Any part of the Chattooga County School District which is described in
33 subsection (a) of this section as being included in a particular district shall nevertheless
34 not be included within such district if such part is not contiguous to such district. Such
35 noncontiguous part shall instead be included within that district contiguous to such part
36 which contains the least population according to the United States decennial census
37 of 2020 for the State of Georgia."

38 **SECTION 2.**

39 Said Act is further amended by repealing subsection (e) of Section 3.

SECTION 3.

41 (a) Those members of the Board of Education of Chattooga County who are serving as such
42 on the effective date of this Act and any person selected to fill a vacancy in any such office
43 shall continue to serve as such members until the regular expiration of their respective terms
44 of office and upon the election and qualification of their respective successors.

45 (b) Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective date of this Act,
46 shall continue to be designated as Districts 1, 2, 3, 4, and 5, respectively, but as newly
47 described under this Act, and on and after the effective date of this Act, such members of the
48 board serving from those former districts shall be deemed to be serving from and
49 representing their respective districts as newly described under this Act.

50

SECTION 4.

51 The provisions of this Act necessary to conduct elections for the members of the Board of
52 Education of Chattooga County in 2022 shall become effective upon the approval of this Act
53 by the Governor or upon its becoming law without such approval. The remaining provisions
54 of this Act shall become effective on January 1, 2023.

SECTION 5.

56 All laws and parts of laws in conflict with this Act are repealed.
