The Senate Committee on Higher Education offered the following substitute to SB 397:

A BILL TO BE ENTITLED AN ACT

- 12 replacing "general educational development (GED)" with "state approved high school
- 13 equivalency (HSE)" in Code Section 15-10-22, relating to qualifications and restrictions on
- 14 the practice of law for magistrates.

SECTION 2.

- 16 Title 20 of the Official Code of Georgia Annotated, related to education, is amended by
- 17 replacing "general educational development" or "general educational development (GED)"
- 18 with "state approved high school equivalency (HSE)" wherever either of the former phrases
- 19 occur in:
- 20 (1) Code Section 20-2-69, relating to requirements and procedures for issuing and
- 21 awarding high school diplomas to honorably discharged World War II Veterans;
- 22 (2) Code Section 20-2-70, relating to requirements and procedures for issuing and
- 23 awarding high school diplomas to honorably discharged Korean Conflict and Vietnam
- 24 Conflict veterans;
- 25 (3) Code Section 20-2-204, relating to paraprofessional and permitted personnel and
- 26 classification of all certified or permitted personnel;
- 27 (4) Code Section 20-2-690, relating to educational entities, requirements for private
- 28 schools and home study programs, and learning pod protection;
- 29 (5) Code Section 20-2-690.1, relating to mandatory education for children between ages
- 30 six and 16;
- 31 (6) Code Section 20-3-66, relating to determination of in-state resident status of students
- 32 for tuition or fees;
- 33 (7) Code Section 20-3-395, relating to definitions relative to direct loans to students on the
- 34 basis of need and merit;
- 35 (8) Code Section 20-3-400.1, relating to definitions relative to graduate on time loans;
- 36 (9) Code Section 20-3-405.1, relating to definitions relative to education for public service
- 37 student loan;
- 38 (10) Code Section 20-3-411, relating to definitions relative to tuition equalization grants
- 39 at private colleges and universities;
- 40 (11) Code Section 20-3-519.2, relating to eligibility requirements for a HOPE scholarship
- 41 and award amount; and

42 (12) Code Section 20-3-660, relating to tuition waiver program for qualifying foster and

43 adopted individuals.

44 SECTION 3.

- 45 Said title is further amended in Code Section 20-3-519, relating to definitions relative to
- 46 HOPE scholarships and grants, by revising paragraph (13.1) as follows:
- 47 "(13.1) 'HOPE GED HSE voucher' means a Helping Outstanding Pupils Educationally
- 48 general educational development (GED) state approved high school equivalency (HSE)
- 49 diploma voucher for postsecondary education awarded issued in accordance with Code
- 50 Section 20-3-519.6."

SECTION 4.

- 52 Said title is further amended by revising Code Section 20-3-519.6, relating to HOPE GED
- 53 vouchers, as follows:

- 55 Subject to the amounts appropriated by the General Assembly and provisions relating to
- 56 the shortfall reserve in Code Section 50-27-13, a HOPE GED HSE voucher in the amount
- 57 of \$500.00 shall be available once to each eligible student who receives pre-certification
- 58 from receiving a general educational development (GED) diploma awarded by the
- 59 Department of Technical and Adult Education, now known as the Technical College
- 60 System of Georgia (TCSG), to take an approved examination seeking a diploma through
- 61 the high school equivalency (HSE) program. TCSG, upon issuance of a voucher in
- accordance with this paragraph, shall invoice the Georgia Student Finance Commission in
- accordance with rules, regulations, and instructions of the commission providing for
- 64 identification of each student and compliance with this program after June 30, 1993. Such
- of voucher shall be issued to such student upon enrollment in any eligible postsecondary
- 66 institution in Georgia within 24 months from the date the general educational development

67 (GED) diploma was awarded to the student and may only be used to cover postsecondary
68 costs of attendance at such institution; provided, however, that for an individual who
69 becomes eligible for such voucher while he or she is incarcerated in a penal institution in
70 this state, such voucher may be used by such individual within 24 months from the date of
71 release from the penal institution."

73 Said title is further amended in Code Section 20-4-11, relating to the powers of the state

72 SECTION 5.

board of the Technical College System of Georgia, by revising division (2)(B)(ii) as follows: 74 75 "(ii) Standards and requirements for the attainment of a high school equivalency 76 certificate which shall be comparable to the high school graduation requirements set 77 by the State Board of Education for public school programs and which shall also be 78 at least equal to the requirements established for a general educational development 79 (GED) diploma by a nationally recognized college and career readiness standard for 80 adult education. The state board shall also adopt and administer an instrument to 81 measure the level of achievement required to obtain a high school equivalency 82 certificate; and"

SECTION 6.

Title 25 of the Official Code of Georgia Annotated, relating to fire protection and safety, is amended by replacing "general education development equivalency" with "state approved high school equivalency (HSE) diploma" in Code Section 25-4-8, relating to qualifications of firefighters generally.

SECTION 7.

89 Title 40 of the Official Code of Georgia Annotated, relating to motor vehicles and traffic, is 90 amended by replacing "general educational development (GED)" with "state approved high

91 school equivalency (HSE)" in Code Section 40-5-22, relating to requirements for issuance

- 92 of instruction permit or driver's license to person under 18 years of age, authority of
- 93 department to issue or renew a driver's license, probationary license, limited driving permit,
- 94 or ignition interlock device limited driving permit.

95 SECTION 8.

- 96 Title 42 of the Official Code of Georgia Annotated, relating to penal institutions, is amended
- 97 by replacing "the general educational development (GED)" with "a state approved high
- 98 school equivalency (HSE)" in Code Section 42-3-50, relating to definitions relative to
- 99 community service and assignment of community service for personal gain prohibited.

SECTION 9.

- 101 Said title is further amended by replacing "general educational development (GED)" with
- 102 "state approved high school equivalency (HSE)" wherever the former phrase occurs in:
- 103 (1) Code Section 42-9-44, relating to terms and conditions of parole, adoption of general
- and special rules, violation of parole, and certain parolees or releasees to obtain high school
- diploma or general educational development (GED) diploma; and
- 106 (2) Code Section 42-9-45, relating to general rule-making power relative to grants of
- pardons, paroles, and other relief.

108 **SECTION 10.**

- 109 Title 43 of the Official Code of Georgia Annotated, relating to professions and businesses,
- 110 is amended by replacing "GED", "general education development", "general educational
- 111 development", or "general educational development (GED)" with "state approved high
- 112 school equivalency (HSE)" wherever any of the former phrases occur in:
- (1) Code Section 43-6-11, relating to qualifications of applicants for auctioneer's licenses;

114 (2) Code Section 43-10-2, relating to creation of the board of cosmetology and barbers,

- members, meetings, officers, and powers;
- 116 (3) Code Section 43-10-9, relating to application for certificate of registration for barbers
- 117 and cosmetologists;
- 118 (4) Code Section 43-10-12, relating to regulation and licenses for schools, teachers, and
- instructors, registration of apprentices, and certification as teacher by Department of
- 120 Education relative to barbers and cosmetologists;
- 121 (5) Code Section 43-18-41, relating to qualifications of embalmer or funeral director
- 122 applicants;
- 123 (6) Code Section 43-18-50, relating to application for funeral service apprenticeship and
- 124 period of apprenticeship; and
- 125 (7) Code Section 43-26-38, relating to license by endorsement and temporary permit for
- 126 licensed practical nurses.

127 **SECTION 11.**

- 128 Said title is further amended by replacing "general educational development (GED)
- 129 equivalency" with "state approved high school equivalency (HSE)" in Code Section
- 130 43-10A-7, relating to licensing requirement and exceptions for professional counselors,
- 131 social workers, and marriage and family therapists.
