## A RESOLUTION

- 1 Encouraging each public school in this state to study the Civil Rights Era and related subjects
- 2 described herein to affirm the commitment of the free peoples of this state to reject bigotry,
- 3 to champion equal protection under the law as a foundational principle of our republic, and
- 4 to act in opposition to injustice wherever it may occur; and for other purposes.
- 5 WHEREAS, during the period in American history known as the Civil Rights Era,
- 6 reform-minded Americans organized to press for a rejection of the doctrine of "separate but
- 7 equal" and to repeal the Jim Crow-era laws in the United States that embodied such doctrine;
- 8 and
- 9 WHEREAS, one of the universal lessons of the Civil Rights Era is that hatred on the basis
- 10 of immutable characteristics, not just race or ethnicity, but also characteristics such as
- 11 nationality, religious belief, disability, or sex, can overtake any nation or society, leading to
- 12 profound injustice; and
- WHEREAS, there is no greater authority on the destructive nature of bigotry, nor is there a
- better cure, than the work and philosophy of Dr. Martin Luther King, Jr., and his principles
- of nonviolent social justice toward productive goals; and

16 WHEREAS, it is vital to the future of our constitutional republic that we build empathy in

- our students by inspiring them to think and talk about why and how to pursue the greater
- 18 good of universal civil rights; and
- 19 WHEREAS, a curriculum for the study of the Civil Rights Era could serve to educate
- 20 students about the natural law and natural rights principles that informed the leadership of
- 21 Dr. Martin Luther King, Jr., in the civil rights movement and the tactics and strategies of
- 22 nonviolent resistance that he championed in response to such Jim Crow laws; to educate
- 23 students about the Civil Rights Era and the universal lesson that hatred on the basis of
- 24 immutable characteristics such as race, sex, or ethnicity or other characteristics such as
- 25 nationality, religious belief, or disability can overtake any nation or society and lead to
- 26 profound injustice; and to reinforce such lessons, a curriculum is needed for studying the
- 27 events of the Civil Rights Era and other acts of discriminatory injustice around the world.
- 28 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
- 29 each public school in this state is encouraged to study the Civil Rights Era and related
- 30 subjects described herein to affirm the commitment of the free peoples of this state to reject
- 31 bigotry, to champion equal protection under the law as a foundational principle of our
- 32 republic, and to act in opposition to injustice wherever it may occur.
- 33 BE IT FURTHER RESOLVED that the House of Representatives recommends that each
- 34 public school in this state is encouraged to include in its curriculum the study of the events
- of the Civil Rights Era; the natural law and natural rights principles that the Rev. Dr. Martin
- 36 Luther King, Jr., drew from that informed his leadership of the civil rights movement; and
- 37 the tactics and strategies of nonviolent resistance that he championed in response to such Jim
- 38 Crow laws of that era.
