## A RESOLUTION

1 Commending the Nation of Israel for its meaningful and mutually beneficial relationship  
2 with the United States and with the State of Georgia; and for other purposes.

3 WHEREAS, the United States, having been the first country to recognize Israel as an  
4 independent nation and as Israel's principal ally, has enjoyed a close and mutually beneficial  
5 relationship with Israel and her people; and

6 WHEREAS, the United States is a nation of immigrants, and Israeli-Americans contribute  
7 invaluable innovations and skills that enhance our quality of life and promote the economic  
8 prosperity of our state and country; and

9 WHEREAS, Israel is one of the smallest countries in the world, yet it is also one of the world  
10 leaders in technology and innovation as well as a world leader in the number of start-ups per  
11 capita; and

12 WHEREAS, Israel is also an "Impact Nation," harnessing its technological innovation for  
13 the greater good to address global challenges and goals, such as sustainable energy, water  
14 management, cyber security, and medical innovations, to name a few; and

15 WHEREAS, Israel is the greatest friend and ally of the United States in the Middle East, and  
16 the values of our two nations are so intertwined that it is impossible to separate one from the  
17 other; and

18 WHEREAS, in 1994, Georgia established an official representation in Israel through the  
19 Georgia Department of Economic Development, which has played an important role in  
20 further strengthening our bilateral relations in trade, academia, tourism, and more; and

21 WHEREAS, there is a special bond of friendship between the citizens of Georgia and Israel  
22 that inspires the people of Georgia to stand with the people of Israel in solidarity and  
23 welcome all opportunities to grow our already deep relationship at all levels, including  
24 cultural, academic, and business endeavors; and

25 WHEREAS, the strong bond between the State of Georgia and Israel is represented by  
26 cultural, economic, academic, and research and development exchanges that contribute  
27 material to all Georgians, exemplified by the robust exchanges of Georgia's law enforcement  
28 professionals with Israel through the Georgia International Law Enforcement Exchange  
29 (GILEE); and

30 WHEREAS, Georgia is proud to serve as home to the Israeli Consulate General to the  
31 Southeastern United States; and

32 WHEREAS, today, over 100 Georgia companies have discovered the benefits of doing  
33 business in Israel, and over 90 Israeli companies have established headquarters, operation  
34 centers, or manufacturing facilities in Georgia, with trade sectors including a wide range of  
35 fields such as fintech, cyber security, health care, aerospace, E-commerce and agritech; and

36 WHEREAS, the United States played a key role in the historic Abraham Accords,  
37 normalizing relations between Israel, the United Arab Emirates, and Bahrain; and

38 WHEREAS, the Abraham Accords paved the way for further regional cooperation and a new  
39 era of peace and economic prosperity between Israel and Arab countries working together  
40 for a better future for their peoples; and

41 WHEREAS, the deepening regional ties sparked by the Abraham Accords are opening  
42 further opportunities for expanding economic relations between Georgia, the State of Israel,  
43 and other countries in the Middle East.

44 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body  
45 commend Israel for its meaningful and mutually beneficial relationship with the United  
46 States and with the State of Georgia and support Israel in its legal, historical, and moral right  
47 to its re-established independence and recognize the Jewish people's right to  
48 self-determination in their ancient homeland.

49 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed  
50 to make an appropriate copy of this resolution available for distribution to the Consul  
51 General of Israel to the Southeastern United States.
