The Senate Committee on State and Local Governmental Operations offered the following substitute to HB 1541:

A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act changing the compensation of the clerk of the superior court, the sheriff,

- 3 approved February 9, 1949 (Ga. L. 1949, p. 427), as amended, particularly by an Act
- 4 approved April 28, 2016 (Ga. L. 2016, p. 3896), and by an Act approved May 2, 2017 (Ga.
- 5 L. 2017, p. 3617), so as to change the compensation of the sheriff, chief deputy, the assistant
- 6 chief deputy, and the executive assistant to the sheriff; to remove provisions relating to the
- 7 qualifications of the assistant chief deputy; to provide for related matters; to repeal
- 8 conflicting laws; and for other purposes.

9 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

- 15 L. 2017, p. 3617), is amended by revising Section 5 as follows:

16 "SECTION 5.

17 (a) The sheriff of Cobb County shall be paid an amount not to exceed \$170,000.00 per 18 year in equal monthly installments from the funds of Cobb County.

19 (b) The sheriff of Cobb County shall have one chief deputy whose salary shall not exceed 20 \$159.665.00 per year, approved by the governing authority of Cobb County to be paid in 21 equal monthly installments from the funds of Cobb County. The chief deputy sheriff shall 22 possess the same qualifications for office as required for the sheriff. The chief deputy shall 23 serve at the pleasure of the sheriff. Each candidate for the office of sheriff of Cobb County 24 shall, at the time he or she qualifies to run for the office of sheriff, designate and certify to 25 the judge of the probate court the name of the person who shall be his or her chief deputy 26 sheriff. In the event the office of sheriff becomes vacant by death, resignation, or 27 otherwise, the vacancy shall be filled until the next general election by said chief deputy, 28 who shall in such event enter upon the performance of said duties upon taking the oath of 29 office prescribed by law for the sheriff of Cobb County. The chief deputy sheriff is 30 authorized, when directed by the sheriff, to discharge any and all of the duties and powers 31 of the sheriff. In addition to said chief deputy, said sheriff shall be authorized to name and 32 appoint such additional deputies as shall be approved from time to time by the governing 33 authority of Cobb County. The salaries of said additional deputies shall be set by the 34 governing authority of Cobb County; provided, however, that said salaries shall not be less 35 than \$4,880.00 per annum per each additional deputy approved by said governing authority 36 of Cobb County. In addition to said chief deputy and other deputies provided for in this 37 subsection, the sheriff of Cobb County shall be authorized to employ the clerical help 38 necessary to perform properly the functions and duties of his or her office, provided that 39 the number of employees and salaries or other compensation to be paid to each shall first 40 be approved by the governing authority of Cobb County.

(c) In addition to those employees provided for by subsection (b) of this section, there is created the office of assistant chief deputy for Cobb County. The assistant chief deputy

43 shall be appointed by the sheriff, shall be under his or her direct supervision and control, 44 and shall serve at the pleasure of the sheriff. The salary of the assistant chief deputy shall 45 not exceed \$155,067.00 per year, approved by the governing authority of Cobb County to 46 be paid in equal monthly installments from the funds of Cobb County. 47 (d) In addition to those employees provided for in subsections (b) and (c) of this section, 48 there is created the position of executive assistant to the sheriff. The executive assistant 49 shall be appointed by the sheriff, shall be under his or her direct supervision and control, 50 and shall serve at the pleasure of the sheriff. The sheriff shall establish such qualifications, 51 education, and experience as he or she deems necessary for the individual appointed to the 52 position of executive assistant. The salary of the executive assistant shall not exceed 53 \$83,261.00 per year, approved by the governing authority of Cobb County to be paid in 54 equal monthly installments from the funds of Cobb County."

55 SECTION 2.

56 All laws and parts of laws in conflict with this Act are repealed.
