A BILL TO BE ENTITLED AN ACT

1 To amend Code Section 16-6-4 of the Official Code of Georgia Annotated, relating to child 2 molestation and aggravated child molestation, so as to provide that each act of child 3 molestation shall be charged as a separate offense; to amend Code Section 16-12-100 of the 4 Official Code of Georgia Annotated, relating to sexual exploitation of children, reporting violation, civil forfeiture, and penalties, so as to specify that an offender can be charged and 5 6 convicted for each separate image or depiction; to amend Article 3 of Chapter 12 of Title 16 7 of the Official Code of Georgia annotated, relating to obscenity and related offenses, so as 8 to provide definitions, regulations, and penalties involving use of commercial social 9 networking websites to commit sexual misconduct; to provide for severability; to provide for 10 related matters; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

Code Section 16-6-4 of the Official Code of Georgia Annotated, relating to child molestation
and aggravated child molestation, is amended by revising subsection (a) and by adding a new
subsection to read as follows:

16 "(a) A person commits the offense of child molestation when such person:

(1) Does any an immoral or indecent act to or in the presence of or with any child under
the age of 16 years with the intent to arouse or satisfy the sexual desires of either the child
or the person; or

20 (2) By means of an electronic device, transmits images of a person engaging in,
21 inducing, or otherwise participating in any an immoral or indecent act to a child under the
22 age of 16 years with the intent to arouse or satisfy the sexual desires of either the child
23 or the person.

24 (a.1) For purposes of this Code section, when a person does an immoral or indecent act

25 involving touching of any child under the age of 16 years with the intent to arouse or

26 <u>satisfy the sexual desires of the child or the person, and such person touches such child in</u>

27 <u>multiple areas of such child's body, the touching of each area shall constitute a separate</u>

28 <u>offense of child molestation.</u>"

SECTION 2.

30 Code Section 16-12-100 of the Official Code of Georgia Annotated, relating to sexual 31 exploitation of children, reporting violation, civil forfeiture, and penalties, is amended by 32 revising paragraphs (5), (6), (7), and (8) of subsection (b) and by adding a new subsection 33 to read as follows:

34 "(5) It is unlawful for any person knowingly to create, reproduce, publish, promote, sell,
35 distribute, give, exhibit, or possess with intent to sell or distribute any <u>a</u> visual medium
36 which depicts a minor or a portion of a minor's body engaged in any sexually explicit
37 conduct.

38 (6) It is unlawful for any person knowingly to advertise, sell, purchase, barter, or
 39 exchange any <u>a</u> medium which provides information as to where any visual medium

40	which depicts a minor or a portion of a minor's body engaged in any sexually explicit
41	conduct can be found or purchased.
42	(7) It is unlawful for any person knowingly to bring or cause to be brought into this state
43	any <u>a</u> material which depicts a minor or a portion of a minor's body engaged in any
44	sexually explicit conduct.
45	(8) It is unlawful for any person knowingly to possess or control $\frac{1}{2}$ material which

- 46 depicts a minor or a portion of a minor's body engaged in any sexually explicit conduct."
- 47 "(b.1) For any violation of paragraph (5), (6), (7), or (8) of subsection (b) of this Code
- 48 section involving multiple visual mediums, mediums, or materials, each visual medium,
- 49 medium, or material connected to such violation shall constitute a separate offense."

SECTION 3.

51 Article 3 of Chapter 12 of Title 16 of the Official Code of Georgia Annotated, relating to

- 52 obscenity and related offenses, is amended by adding a new Code section to read as follows:
- 53 ″<u>16-12-100.4.</u>
- 54 (a) As used in this Code section, the term:
- 55 (1) 'Commercial social networking website' includes any website, application, portal,
- 56 <u>or other means of accessing the internet that:</u>
- 57 (A) Is operated by a person that derives revenue from membership fees, advertising,
- 58 or other sources related to the operation of the website, application, portal, or other
- 59 <u>means of accessing the internet;</u>
- 60 (B) Allows users to create personal web pages or profiles that contain the user's name
- 61 or nickname, photographs of the user, and other personal information; and
- 62 (C) Provides users or visitors a mechanism by which to communicate with others, such
- 63 <u>as a message board, chat room, or instant messenger.</u>

64	Such term shall not include a website that is either owned or operated by a local, state,
65	or federal governmental entity or that has as its primary purpose the facilitation of
66	commercial transactions, the dissemination of news, the discussion of political or social
67	issues, or professional networking.
68	(2) 'High-risk sex offender' means any individual who is registered with the State Sexual
69	Offender Registry and who has been classified as a sexually dangerous predator pursuant
70	to Code Section 42-1-14.
71	(b) It shall be unlawful for any high-risk sex offender to access or use any commercial
72	social networking website to:
73	(1) Communicate with a person who the offender believes is under 16 years of age;
74	(2) Contact a person who the offender believes is under 16 years of age;
75	(3) Pose falsely as a person under 16 years of age; or
76	(4) Gather information about a person who the offender believes is under 16 years of
77	age.
78	(c) For purposes of determining jurisdiction, an offense shall be deemed to be committed
79	in this state if the transmission that constitutes the offense either originates in this state or
80	is received in this state.
81	(d) Any person that violates this Code section shall be guilty of a felony and, upon
82	conviction thereof, shall be punished by imprisonment for not less than one nor more than
83	ten years and by a fine of not more than \$10,000.00.
84	(e) This Code section shall be severable in accordance with Code Section 1-1-3, relating
85	to severability."
