

House Bill 705

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act to incorporate the City of Milton in Fulton County, Georgia, approved  
2 March 29, 2006 (Ga. L. 2006, p. 3554), as amended, so as to change the description of the  
3 election districts for the city council; to provide for definitions and inclusions; to provide for  
4 manner of election; to provide for the continuation in office of current members; to provide  
5 for related matters; to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 An Act to incorporate the City of Milton in Fulton County, Georgia, approved  
9 March 29, 2006 (Ga. L. 2006, p. 3554), as amended, is amended by revising subsections (c)  
10 through (f) of Section 2.11 as follows:

11 "(c)(1) The city shall be divided into three districts. Each district shall be entitled to two  
12 councilmembers who shall be elected as provided in this charter. Six councilmembers  
13 shall be elected from the districts provided for in this paragraph. Two councilmembers  
14 shall be elected from District 1, and such seats shall be designated as Post 1 and Post 2.  
15 Two councilmembers shall be elected from District 2, and such seats shall be designated  
16 as Post 3 and Post 4. Two councilmembers shall be elected from District 3, and such

17 seats shall be designated as Post 5 and Post 6. Districts 1, 2, and 3 shall be and  
18 correspond to those three numbered districts described in Appendix B attached to and  
19 made a part of this Act and further identified as 'User: Milton Plan Name:  
20 MiltonCC-2023 Plan Type: Local'. Each candidate for election to the council other than  
21 the mayor must reside in the council district he or she seeks to represent, but such  
22 districts shall be residency districts only and not voting districts.

23 (2) For the purposes of such plan:

24 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
25 provided in the report of the Bureau of the Census for the United States decennial  
26 census of 2020 for the State of Georgia. The separate numeric designations in a district  
27 description which are underneath a VTD heading shall mean and describe individual  
28 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
29 United States decennial census of 2020 for the State of Georgia; and

30 (B) Except as otherwise provided in the description of any district, whenever the  
31 description of any district refers to a named city, it shall mean the geographical  
32 boundaries of that city as shown on the census maps for the United States decennial  
33 census of 2020 for the State of Georgia.

34 (3) Any part of the City of Milton which is not included in any district described in  
35 paragraph (1) of this subsection shall be included within that district contiguous to such  
36 part which contains the least population according to the United States decennial census  
37 of 2020 for the State of Georgia.

38 (4) Any part of the City of Milton which is described in paragraph (1) of this subsection  
39 as being included in a particular district shall nevertheless not be included within such  
40 district if such part is not contiguous to such district. Such noncontiguous part shall  
41 instead be included within that district contiguous to such part which contains the least  
42 population according to the United States decennial census of 2020 for the State of  
43 Georgia.

44 (5) Those members of the city council who are serving as such on the effective date of  
45 this Act and any person selected to fill a vacancy in any such office shall continue to  
46 serve as such members until the regular expiration of their respective terms of office and  
47 upon the election and qualification of their respective successors.

48 (d) Districts 1, 2, and 3, as they exist immediately prior to the effective date of this Act,  
49 shall continue to be designated as Districts 1, 2, and 3, respectively, but as newly described  
50 under this Act, and on and after the effective date of this Act, such members of the council  
51 serving from those former districts, and their respective posts, shall be deemed to be  
52 serving from and representing their respective districts and posts as newly described under  
53 this Act.

54 (e) The mayor and each councilmember shall be elected by the qualified electors of the  
55 city at large.

56 (f) The time for holding regular municipal elections shall be on the Tuesday next following  
57 the first Monday in November of each odd-numbered year beginning in 2023. Successors  
58 to the mayor and councilmembers shall be elected at the municipal election immediately  
59 preceding the expiration of the respective terms of office and shall take office on the first  
60 day of January immediately following their election for terms of four years and until their  
61 successors are elected and qualified."

62 **SECTION 2.**

63 All laws and parts of laws in conflict with this Act are repealed.
