A BILL TO BE ENTITLED
AN ACT

1 To amend Code Section 20-2-161 of the Official Code of Georgia Annotated, relating to the
2 Quality Basic Education Formula, so as to provide that the middle grades program is funded
3 at the same program weight as the middle school program; to provide for related matters; to
4 repeal conflicting laws; and for other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 SECTION 1.

7 Code Section 20-2-161 of the Official Code of Georgia Annotated, relating to the Quality
8 Basic Education Formula, by striking subsection (b) in its entirety and inserting in lieu
9 thereof the following:

10 "(b) As the cost of instructional programs varies depending upon the teacher-student ratios
11 and specific services typically required to address the special needs of students enrolled,
12 state authorized instructional programs shall have the following program weights and
13 teacher-student ratios:
