A BILL TO BE ENTITLED
AN ACT

1 To amend an Act creating the Douglas County Board of Education, approved April 13, 1982
2 (Ga. L. 1982, p. 4786), as amended, particularly by an Act approved February 27, 2012 (Ga.
3 L. 2012, p. 3717), so as to provide for compensation of members; to provide for related
4 matters; to provide an effective date; to repeal conflicting laws; and for other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 style="text-align:center">**SECTION 1.**

7 An Act creating the Douglas County Board of Education, approved April 13, 1982 (Ga. L.
8 1982, p. 4786), as amended, particularly by an Act approved February 27, 2012 (Ga. L. 2012,
9 p. 3717), is amended by revising subsection (j) of Section 1 as follows:

10 "(j)(1) The chairperson of the board of education shall be compensated in equal monthly
11 installments from the general funds of the board of education the sum of 20 percent of the
12 base salary for a superior court judge as set forth in O.C.G.A. Section 45-7-4. The vice
13 chairperson of the board of education shall be compensated in equal monthly installments
14 from the general funds of the board of education the sum of 18 percent of the base salary
15 for a superior court judge as set forth in O.C.G.A. Section 45-7-4. The remaining board
16 members shall be compensated in equal monthly installments from the general funds of
17 the board of education the sum of 16 percent of the base salary for a superior court judge
18 as set forth in O.C.G.A. Section 45-7-4. This paragraph shall apply until December 31,
19 2014.

20 (2) On January 1, 2015, the compensation of the chairperson, vice chairperson, and each
21 of the remaining board members shall be reduced by 10 percent and each resulting
22 amount shall be such member's compensation. After January 1, 2015, the compensation
23 of the chairperson, vice chairperson, and each of the remaining board members shall be
24 increased in any year in which the General Assembly includes in an Appropriations Act
25 an increase from the previous fiscal year in the minimum salary schedule for teachers and
26 such increase in the compensation of the chairperson, vice chairperson, and each of the

27 remaining board members shall be by the same percentage increase as the increase in the
28 minimum salary base provided in the minimum salary schedule.

29 (3) The members of the board of education shall be reimbursed for actual expenses
30 incurred in carrying out approved board of education business while outside the county.
31 All expenses so incurred shall be paid from the general funds of the board of education on
32 a monthly basis."

33 **SECTION 2.**

34 This Act shall become effective on January 1, 2015.

35 **SECTION 3.**

36 All laws and parts of laws in conflict with this Act are repealed.
