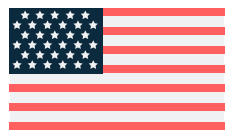


GEORGIA ELECTIONS: VOTER REGISTRATION

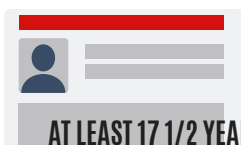
In order to register to vote in Georgia, a person must meet the following criteria:



UNITED STATES CITIZEN



COUNTY RESIDENT



AT LEAST 17 1/2 YEARS OLD TO REGISTER AND AT LEAST 18 YEARS OLD TO VOTE



NOT SERVING A SENTENCE FOR A FELONY INVOLVING MORAL TURPITUDE

NOT FOUND MENTALLY INCOMPETENT BY A JUDGE



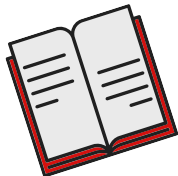
How and where can Georgians register to vote?

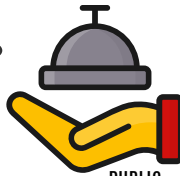

REGISTRATION DEADLINES

GENERAL PRIMARY, GENERAL ELECTION, PRESIDENTIAL PREFERENCE PRIMARY

The FIFTH MONDAY prior to the date of the election or primary

SPECIAL PRIMARY, SPECIAL ELECTION

The FIFTH DAY* after the date of the call for the special primary or election OR the FIFTH MONDAY prior to the date of the election or primary, whichever is LATER

*excluding Saturdays, Sundays, and legal holidays

IF A SPECIAL ELECTION IS HELD ON THE SAME DAY AS A GENERAL ELECTION, THE REGISTRATION DEADLINE WILL BE THE SAME AS THE GENERAL ELECTION DEADLINE

Several federal laws impact Georgia's registration laws and guidelines, including:

NVRA
NATIONAL VOTER REGISTRATION ACT

- KNOWN AS THE "MOTOR VOTER ACT"
- REQUIRES STATES TO OFFER VOTER REGISTRATION OPPORTUNITIES AT STATE MOTOR VEHICLE AGENCIES
- AS A RESULT OF THE NVRA, A MAJORITY OF NEW GEORGIA VOTER REGISTRATIONS COME THROUGH THE DEPARTMENT OF DRIVER SERVICES (DDS)

HAVA
HELP AMERICA VOTE ACT
REQUIRES STATES TO CREATE AND MAINTAIN A COMPUTERIZED STATEWIDE VOTER REGISTRATION LIST

Nationwide, Department of Motor Vehicles registrations accounted for **39.3%** of all voter registrations in 2020 

THE NUMBER OF ACTIVE VOTERS REGISTERED IN GEORGIA CONTINUES TO RISE:

5.4 MILLION 2016 → **6.4 MILLION** 2018 → **7.2 MILLION** 2020

94.9%
OF GEORGIA'S CITIZEN VOTING AGE POPULATION (CVAP) ARE REGISTERED TO VOTE
