

The House Committee on Regulated Industries offers the following substitute to HB 41:

A BILL TO BE ENTITLED  
AN ACT

1 To amend Chapter 4 of Title 43 of Code Section 43-4-11 of the Official Code of Georgia  
2 Annotated, relating to architects, so as to change the qualifications of applicants for  
3 examination or certificate of registration as an architect, so as to allow certain students to  
4 take such examination; to provide for the promulgation of certain rules and regulations; to  
5 provide for related matters; to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 Chapter 4 of Title 43 of the Official Code of Georgia Annotated, relating to architects, is  
9 amended by revising Code Section 43-4-11, relating to qualifications of applicants for  
10 examination or certificate of registration as an architect, as follows:

11 "43-4-11.

12 (a) Any person may apply to the board for such examinations as are required for  
13 certification under this article if qualified as set forth in subsection (b) of this Code section,  
14 or any person who has been registered as an architect by another jurisdiction may apply for  
15 a certificate of registration if qualified as set forth in subsection (c) of this Code section.

16 No person shall be eligible for registration as an architect who has been found by the board  
17 to have committed any of the acts set forth in this article for which an architect's certificate  
18 might be revoked or suspended unless that individual establishes to the satisfaction of the  
19 board that he or she has fully reformed.

20 (b) The examinations shall be the examinations prepared and graded by the National  
21 Council of Architectural Registration Boards (NCARB). The candidate for examination  
22 shall submit to the board satisfactory evidence of one of the following qualifications:

23 (1)(A)(i) A professional degree in architecture from a school or college approved by  
24 the National Architectural Accrediting Board; or

25 (ii) Active participation in a National Council of Architectural Registration Boards  
 26 accepted Integrated Path to Architectural Licensure option within a National  
 27 Architectural Accrediting Board accredited professional degree program in  
 28 architecture; and

29 (B) Practical ~~practical~~ experience as the board, by rules and regulations uniformly  
 30 applied, shall deem appropriate. ~~The board may adopt as its rules and regulations those~~  
 31 ~~guidelines published from time to time by the National Council of Architectural~~  
 32 ~~Registration Boards;~~

33 (2) A minimum of ten years' practical experience, including academic training, following  
 34 completion of high school or the equivalent thereof, as the board, by rules and regulations  
 35 uniformly applied, shall deem appropriate. An individual who intends to qualify as a  
 36 candidate for examination under the provisions of this paragraph shall notify the board  
 37 of such intent in writing prior to July 1, 1985. After July 1, 1985, all candidates for  
 38 examination shall meet the requirements of paragraph (1) of this subsection; provided,  
 39 however, that those candidates and only those candidates who have met the requirements  
 40 of this paragraph shall be admitted as a candidate for examination; or

41 (3) A bachelor's degree in architectural engineering technology from a school or college  
 42 in this state approved by the Accrediting Board for Engineering and Technology, or any  
 43 other bachelor's degree with a substantial concentration in architecture approved by the  
 44 board from a board approved school or college in this state, and at least six years of  
 45 practical experience as the board, by regulations uniformly applied, shall deem  
 46 appropriate. An individual who intends to qualify as a candidate for examination under  
 47 the provisions of this paragraph shall notify the board of such intent in writing prior to  
 48 July 1, 2004. After July 1, 2004, all candidates for examination shall meet the  
 49 requirements of paragraph (1) of this subsection.

50 (c) The applicant for a certificate of registration who has been registered as an architect  
 51 by another jurisdiction shall hold a National Council of Architectural Registration Boards'  
 52 certificate and a certificate of registration in such other jurisdiction, both of which shall be  
 53 current and in good standing in order to meet the requirements of this subsection.

54 (d) The board may require applicants under subsection (c) of this Code section to provide  
 55 such other evidence as the board may require to demonstrate knowledge of professional  
 56 practice.

57 (e) No certificate of registration shall be issued to an applicant under this article, if he or  
 58 she was a candidate for examination under the provisions of paragraph (1) of subsection (b)  
 59 of this Code section, unless and until such applicant for certification shows the board  
 60 satisfactory evidence of a professional degree in architecture from a school or college  
 61 approved by the National Architectural Accrediting Board.

62 (f) The board may promulgate such rules and regulations as may be reasonable and  
63 necessary for the administration and enforcement of this Code section."
