A BILL TO BE ENTITLED
AN ACT

1 To amend an Act to provide for a supplement to the compensation, expenses, and allowances
2 of the district attorney of the Atlantic Judicial Circuit, approved April 11, 1979 (Ga. L. 1979,
3 p. 584), as amended, particularly by an Act approved March 26, 1980 (Ga. L. 1980, p. 1222),
4 so as to provide for the minimum supplement each county in the circuit shall provide to the
5 judges of the superior courts; to provide for related matters; to repeal conflicting laws; and
6 for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act to provide for a supplement to the compensation, expenses, and allowances of the
10 district attorney of the Atlantic Judicial Circuit, approved April 11, 1979 (Ga. L. 1979,
11 p. 584), as amended, particularly by an Act approved March 26, 1980 (Ga. L. 1980, p. 1222),
12 is amended by revising Section 1 as follows:

13 "SECTION 1.

14 (a) Each county lying within the Atlantic Judicial Circuit may supplement the salary of the
15 district attorney of the Atlantic Judicial Circuit in an amount to be determined within the
16 discretion of the county governing authority. Each such supplement may be received and
17 retained by the district attorney of the Atlantic Judicial Circuit and shall be in addition to
18 the compensation, salary, expenses, and allowances otherwise provided by, or pursuant to,
19 law for the district attorney. Each such supplement shall be paid in monthly installments
20 at the time the salary of the district attorney paid from state funds is paid.

21 (b) In addition to the compensation, salary, expenses, and allowances provided to the
22 judges of the superior courts of the Atlantic Judicial Circuit paid from state funds or other
23 sources, the governing authorities of each county lying within the Atlantic Judicial Circuit
24 shall supplement the salary of each judge of the superior courts of the Atlantic Judicial
25 Circuit not less than the following amounts:

- 26 (1) Bryan County - \$750.00 per month;
27 (2) Evans County - \$300.00 per month;
28 (3) Liberty County - \$1,500.00 per month;
29 (4) Long County - \$350.00 per month;
30 (5) McIntosh County - \$375.00 per month; and
31 (6) Tattnall County - \$600.00 per month.
- 32 (c) Each county lying within the Atlantic Judicial Circuit may supplement the salary of
33 each judge of the superior courts of the Atlantic Judicial Circuit more than the amount
34 provided for in subsection (b) of this section at the discretion of the governing authority of
35 each county."

36 **SECTION 2.**

37 All laws and parts of laws in conflict with this Act are repealed.
