A BILL TO BE ENTITLED AN ACT

- 1 To amend Chapter 1 of Title 43 of the Official Code of Georgia Annotated, relating to
- 2 general provisions of professions and businesses, so as to provide for individuals who move
- 3 to the state and establish residency to obtain a license by endorsement to practice certain
- 4 professions and occupations in this state; to provide for requirements; to provide for related
- 5 matters; to provide for an effective date; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

- 8 Chapter 1 of Title 43 of the Official Code of Georgia Annotated, relating to general
- 9 provisions of professions and businesses, is amended by revising Code Section 43-1-34.1,
- 10 relating to expedited license by endorsement for military spouses, as follows:

- 12 (a) As used in this Code section, the term:
- 13 (1) 'License' shall have the same meaning as provided in Code Section 43-1-34.
- 14 (2) 'Military' shall have the same meaning as provided in Code Section 43-1-34.
- 15 (3) 'Other board' shall have the same meaning as provided in Code Section 43-1-34.
- 16 (4) 'Service member' shall have the same meaning as provided in Code Section 43-1-34.

17 (5) 'State' means a state of the United States, the District of Columbia, Puerto Rico, the

- 18 United States Virgin Islands, or any territory or insular possession subject to the
- 19 jurisdiction of the United States.
- 20 (6) 'Transitioning service member' shall have the same meaning as provided in Code
- 21 Section 43-1-34.
- 22 (b) Notwithstanding any other provisions of law, a professional licensing board or other
- board shall issue an expedited license by endorsement to any individual that:
- 24 (1) Is a spouse of a service member or transitioning service member stationed within this
- 25 state;
- 26 (2) Holds a current license to practice such occupation or profession issued by another
- state for which the training, experience, and testing are substantially similar in
- qualifications and scope to the requirements under this state to obtain a license;
- 29 (3) Is in good standing in such other state; and
- 30 (4) Passes any examination that may only be required to demonstrate knowledge of the
- 31 laws and rules and regulations of this state specific to the practice of the profession,
- business, or trade for which such expedited license by endorsement is being sought.
- 33 (c) Notwithstanding any other provisions of law, a professional licensing board or other
- 34 <u>board shall issue a license by endorsement to any individual that:</u>
- 35 (1) Moves from another state and establishes residency in this state;
- 36 (2) Holds a current license to practice such occupation or profession issued by another
- 37 state that was acquired prior to moving from another state and establishing residency in
- 38 this state for which the training, experience, and testing are substantially similar in
- 39 qualifications and scope to the requirements under this state to obtain a license;
- 40 (3) Is in good standing in such other state; and
- 41 (4) Passes any examination that may only be required to demonstrate knowledge of the
- 42 <u>laws and rules and regulations of this state specific to the practice of the profession,</u>
- business, or trade for which such license by endorsement is being sought.

- amend any licensing compact entered into by the State of Georgia."

- 47 This Act shall become effective upon its approval by the Governor or upon its becoming law

- All laws and parts of laws in conflict with this Act are repealed.
