

The Senate Committee on Regulated Industries and Utilities offered the following substitute to SB 45:

A BILL TO BE ENTITLED
AN ACT

1 To amend Chapter 1 of Title 43 of the Official Code of Georgia Annotated, relating to
2 general provisions of professions and businesses, so as to provide for individuals who move
3 to the state and establish residency to obtain a license by endorsement to practice certain
4 professions and occupations in this state; to provide for requirements; to provide for related
5 matters; to provide for an effective date; to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 Chapter 1 of Title 43 of the Official Code of Georgia Annotated, relating to general
9 provisions of professions and businesses, is amended by revising Code Section 43-1-34.1,
10 relating to expedited license by endorsement for military spouses, as follows:

11 "43-1-34.1.

12 (a) As used in this Code section, the term:

13 (1) 'License' shall have the same meaning as provided in Code Section 43-1-34.

14 (2) 'Military' shall have the same meaning as provided in Code Section 43-1-34.

15 (3) 'Other board' shall have the same meaning as provided in Code Section 43-1-34.

16 (4) 'Service member' shall have the same meaning as provided in Code Section 43-1-34.

17 (5) 'State' means a state of the United States, the District of Columbia, Puerto Rico, the
18 United States Virgin Islands, or any territory or insular possession subject to the
19 jurisdiction of the United States.

20 (6) 'Transitioning service member' shall have the same meaning as provided in Code
21 Section 43-1-34.

22 (b) Notwithstanding any other provisions of law, a professional licensing board or other
23 board shall issue an expedited license by endorsement to any individual that:

24 (1) Is a spouse of a service member or transitioning service member stationed within this
25 state;

26 (2) Holds a current license to practice such occupation or profession issued by another
27 state for which the training, experience, and testing are substantially similar in
28 qualifications and scope to the requirements under this state to obtain a license;

29 (3) Is in good standing in such other state; and

30 (4) Passes any examination that may only be required to demonstrate knowledge of the
31 laws and rules and regulations of this state specific to the practice of the profession,
32 business, or trade for which such expedited license by endorsement is being sought.

33 (c) Notwithstanding any other provisions of law, a professional licensing board or other
34 board shall issue a license by endorsement to any individual that:

35 (1) Moves from another state and establishes residency in this state;

36 (2) Holds a current license to practice such occupation or profession issued by another
37 state that was acquired prior to moving from another state and establishing residency in
38 this state for which the training, experience, and testing are substantially similar in
39 qualifications and scope to the requirements under this state to obtain a license;

40 (3) Is in good standing in such other state; and

41 (4) Passes any examination that may only be required to demonstrate knowledge of the
42 laws and rules and regulations of this state specific to the practice of the profession,
43 business, or trade for which such license by endorsement is being sought.

44 ~~(e)~~(d) Nothing contained in this Code section shall be construed to invalidate, override, or
45 amend any licensing compact entered into by the State of Georgia or to permit the issuance
46 of a license without verification under Code Section 50-36-1."

47 **SECTION 2.**

48 This Act shall become effective upon its approval by the Governor or upon its becoming law
49 without such approval.

50 **SECTION 3.**

51 All laws and parts of laws in conflict with this Act are repealed.
