

House Bill 455 (COMMITTEE SUBSTITUTE)

A BILL TO BE ENTITLED
AN ACT

1 To amend Chapter 2 of Title 20 of the Official Code of Georgia Annotated, relating to
2 elementary and secondary education, so as to revise a provision relating to student
3 transportation; to authorize local boards of education to use vehicles other than school buses
4 for the transport of students to and from school related activities; to provide for minimum
5 requirements; to provide for insurance; to provide for related matters; to repeal conflicting
6 laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 Chapter 2 of Title 20 of the Official Code of Georgia Annotated, relating to elementary and
10 secondary education, is amended in Code Section 20-2-188, relating to student
11 transportation, by revising subsection (e) as follows:

12 "(e) The State Board of Education shall establish and require adherence to minimum
13 specifications for vehicles used or contracted to be used by local units of administration for
14 transporting students, including a motor vehicle with a capacity of eight persons or less
15 operated and marked for the transportation of school children to and from school activities,
16 taking into account the factors and circumstances set forth in subsection (a) of this Code

17 section, and shall establish and require adherence to minimum standards and requirements
18 respecting maintenance, repair, inspection, and use of such vehicles and minimum
19 qualifications for the drivers of such vehicles. The state board shall require, monitor, and
20 fund a program of safety instruction in the practices of safe riding and emergency bus
21 evacuation drills for both school bus drivers and students riding school buses."

22 **SECTION 2.**

23 Said chapter is further amended in Part 1 of Article 22, relating to the powers of state and
24 local school officials with respect to school buses, by adding a new Code section to read as
25 follows:

26 "20-2-1076.

27 (a) Local boards of education may authorize the use of vehicles other than school buses
28 for the transport of students to and from school related activities, where appropriate. Such
29 vehicles may include motor vehicles with a capacity of eight persons or less operated and
30 marked for the transportation of school children to and from school activities.

31 (b) Local boards shall comply with all requirements established by the State Board of
32 Education pursuant to Code Section 20-2-188, including minimum standards and
33 requirements, which shall be delineated separately from requirements for school buses; for
34 maintenance, repair, inspection, and use of such vehicles; minimum qualifications for the
35 drivers of such vehicles; and other requirements as deemed necessary by the State Board
36 of Education. Local boards may establish requirements in addition to such minimum state
37 requirements, in the discretion of the local board.

38 (c) Local boards are authorized and required to cause policies of insurance to be issued
39 insuring the students being transported to and from school related activities against bodily
40 injury or death at any time resulting from an accident or collision in which such vehicles
41 are involved. The amount of such insurance shall be within the discretion of each local
42 board of education."

SECTION 3.

44 All laws and parts of laws in conflict with this Act are repealed.
