A BILL TO BE ENTITLED
AN ACT

1 To amend an Act creating a new charter for the City of Powder Springs, approved March 13,
2 1970 (Ga. L. 1970, p. 2760), as amended, particularly by an Act approved May 4, 2017 (Ga.
3 L. 2017, p. 3969), so as to update the boundaries of the city; to provide for related matters;
4 to repeal conflicting laws; and for other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 **SECTION 1.**

7 An Act creating a new charter for the City of Powder Springs, approved March 13, 1970 (Ga.
8 L. 1970, p. 2760), as amended, particularly by an Act approved May 4, 2017 (Ga. L. 2017,
9 p. 3969), is amended by adding a new subparagraph to paragraph (2) of subsection (a) of
10 Section 1.11 as follows:

11 "(D) The boundaries of this city shall also include the following tracts and parcels:

12 Parcel 1

13 Property located at 5455 and 5461 POWDER SPRINGS DALLAS RD more
14 specifically described as follows:

15 ALL THAT TRACT OF PARCEL OF LAND and being in Land Lot 747 of the 19th
16 District, 2nd Section of Cobb County, Georgia and more particularly described as
17 follows:

18 Beginning at a point 700 feet east of where the north right-of-way of the Southern
19 Railroad intersects with the west land lot line of Land Lot 747 at a point marked by an

21 the southwest side o State Highway #6, thence southeasterly along the southwest side
