A BILL TO BE ENTITLED  
AN ACT

1 To amend Article 1 of Chapter 6 of Title 17 of the Official Code of Georgia Annotated,  
2 relating to general provisions regarding bonds and recognizances, so as to redefine the term  
3 "bail restricted offense"; to provide for related matters; to provide for an effective date and  
4 applicability; to repeal conflicting laws; and for other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 Article 1 of Chapter 6 of Title 17 of the Official Code of Georgia Annotated, relating to  
8 general provisions regarding bonds and recognizances, is amended by revising paragraph (1)  
9 of subsection (a) of Code Section 17-6-12, relating to unsecured judicial release,  
10 requirement, and effect of failure of person charged to appear for trial, as follows:

11 "(1) 'Bail restricted offense' means the person is charged with:

12 (A) Any felony ~~An~~ offense of:

13 (i) ~~Murder or felony murder, as defined in Code Section 16-5-1;~~

14 (ii) ~~Armed robbery, as defined in Code Section 16-8-41;~~

15 (iii) ~~Kidnapping, as defined in Code Section 16-5-40;~~

16 (iv) ~~Rape, as defined in Code Section 16-6-1;~~

- 17 ~~(v) Aggravated child molestation, as defined in subsection (c) of Code Section~~

25 ~~(iii) Hijacking a motor vehicle in the first degree;~~

47 **SECTION 2.**

48 This Act shall become effective on July 1, 2022, and shall apply to all offenses committed

49 on or after such date. This Act shall not affect any actions taken prior to July 1, 2022.

50 **SECTION 3.**

51 All laws and parts of laws in conflict with this Act are repealed.
