A RESOLUTION

1 Recognizing Mr. Mike Berg and dedicating a intersection in his honor; and for other
2 purposes.

3 WHEREAS, Mr. Mike Berg has long been recognized for the vital role that he plays in
4 leadership and his deep personal commitment to the welfare of the citizens of this state; and

5 WHEREAS, a graduate of Sylvan Hills High School, Mr. Berg earned a bachelor's degree
6 from Georgia State University; and

7 WHEREAS, he served as a guardian of this nation's freedom and liberty with the United
8 States Army and retired from the position of manager from the Georgia Power Company; and

9 WHEREAS, Mr. Berg is the principal for Mike Berg and Associates, Inc., a government and
10 business strategic planning company, and serves as the chief financial officer for Marketing
11 Incentives, which sells promotional marketing incentives; and

12 WHEREAS, he is an active member of Rotary International, including the South Gwinnett
13 Club, Snellville Club, and Gwinnett Sunrise Club, where he has served as president, a major

14 donor, a GSRP Will Watt fellow, benefactor, Paul Harris Society member, RLI graduate, and
15 area four assistant governor; and

16 WHEREAS, his leadership and guidance have been instrumental to numerous organizations,
17 including Lake Lanier Association, Coosa North Georgia State Water Planning Commission,
18 and Drawdown Georgia; and

19 WHEREAS, Mr. Berg has served as president of the Association of County Commissioners
20 of Georgia, chairman of the Board of Commissioners of Dawson County, county
21 commissioner for Gwinnett County District 3, board member for Institute of Georgia
22 Environmental Leadership, chairman of the Georgia State Public Defender Council, board
23 member for the State Parent Teacher Association, and founder and chairman of Gwinnett
24 United in Drug Education; and

25 WHEREAS, it is fitting and proper that the outstanding accomplishments of this remarkable
26 and distinguished Georgian be appropriately recognized by dedicating an intersection in his
27 honor.

28 NOW, THEREFORE, BE IT RESOLVED AND ENACTED BY THE GENERAL
29 ASSEMBLY OF GEORGIA that the intersection of State Route 400 and Dawson Forest
30 Road in Dawson County is dedicated as the Mike Berg Intersection.

31 BE IT FURTHER RESOLVED that the Department of Transportation is authorized and
32 directed to erect and maintain appropriate signs dedicating the Mike Berg Intersection.

33 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed
34 to make appropriate copies of this resolution available for distribution to Mr. Mike Berg and
35 to the Department of Transportation.
