

House Bill 1601

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act revising, superseding, and consolidating the laws creating and governing  
2 the Board of Commissioners of Echols County, approved February 3, 1953 (Ga. L. 1953,  
3 Jan.-Feb. Sess., p. 2054), as amended, particularly by an Act approved March 27, 2012 (Ga.  
4 L. 2012, p. 4575), so as to increase the size of the board of commissioners; to provide for  
5 residency requirements; to provide for the description of the commissioner districts and  
6 posts; to define certain terms and provide for certain inclusions; to provide for election of  
7 members; to provide for initial terms; to provide for continuation in office of current  
8 members; to provide for related matters; to provide effective dates; to repeal conflicting laws;  
9 and for other purposes.

10 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

11 **SECTION 1.**

12 An Act revising, superseding, and consolidating the laws creating and governing the Board  
13 of Commissioners of Echols County, approved February 3, 1953 (Ga. L. 1953, Jan.-Feb.  
14 Sess., p. 2054), as amended, particularly by an Act approved March 27, 2012 (Ga. L. 2012,  
15 p. 4575), is amended by revising Section 2 as follows:

## 16 "SECTION 2.

17 (a) There shall be a Board of Commissioners of Echols County, to consist of five persons  
18 to be elected as provided for in this Act. In order to be elected as a member of the board  
19 from a commissioner district, a person must have resided in that district for at least 12  
20 months prior to election thereto and must receive a majority of the votes cast for such  
21 office in that district. At the time of qualifying for election as a member of the board from  
22 a district, each candidate for such office shall specify the district for which that person is  
23 a candidate. A person elected as a member of the board from a district must continue to  
24 reside in that district during the person's term of office or such office shall thereupon  
25 become vacant. Elections of members of the board shall be held in accordance with  
26 Chapter 2 of Title 21 of the O.C.G.A., the 'Georgia Election Code.'

27 (b) For the purpose of electing members of the board of commissioners, Echols County  
28 shall be divided into three commissioner districts. Commissioner Districts 1 and 2 shall  
29 each have two posts. Commissioner Districts 1, 2, and 3 shall be and correspond to those  
30 three numbered districts described in Appendix A attached to and made a part of this Act  
31 and further identified as 'User: Echols Plan Name: EcholsCC-2022 Plan Type: Local'.

32 (c)(1) For the purposes of such plan:

33 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
34 provided in the report of the Bureau of the Census for the United States decennial  
35 census of 2020 for the State of Georgia. The separate numeric designations in a district  
36 description which are underneath a VTD heading shall mean and describe individual  
37 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
38 United States decennial census of 2020 for the State of Georgia; and

39 (B) Except as otherwise provided in the description of any district, whenever the  
40 description of any district refers to a named city, it shall mean the geographical  
41 boundaries of that city as shown on the census maps for the United States decennial  
42 census of 2020 for the State of Georgia.

43 (2) Any part of Echols County which is not included in any district described in  
44 subsection (b) of this section shall be included within that district contiguous to such part  
45 which contains the least population according to the United States decennial census  
46 of 2020 for the State of Georgia.

47 (3) Any part of Echols County which is described in subsection (b) of this section as  
48 being included in a particular district shall nevertheless not be included within such  
49 district if such part is not contiguous to such district. Such noncontiguous part shall  
50 instead be included within that district contiguous to such part which contains the least  
51 population according to the United States decennial census of 2020 for the State of  
52 Georgia.

53 (c) Except as provided in subsection (d) of this section, members of the board of  
54 commissioners shall serve four-year terms of office and until their successors are elected  
55 and qualified.

56 (d)(1) The initial member of the board from District 1 Post 1 as newly described under  
57 this section shall be elected at the general election held in November, 2024. The  
58 commissioner elected at such election shall serve a four-year term of office.

59 (2) The initial member of the board elected from District 1 Post 2 as newly described  
60 under this section shall be elected at the general election held in November, 2024, and the  
61 commissioner elected at such election shall serve an initial term of office of two years.  
62 The successor to such commissioner shall be elected at the general election held in  
63 November, 2026, and such successor and all subsequent successors shall serve a  
64 four-year term of office.

65 (3) The initial member of the board elected from District 2 Post 1 as newly described  
66 under this section shall be elected at the general election held in November, 2024. The  
67 commissioner elected at such election shall serve a four-year term of office.

68 (4) The initial member of the board from District 2 Post 2 as newly described under this  
69 section shall be Kenneth Petty, and on and after the effective date of this section such

70 commissioner shall be deemed to be serving from and representing District 2 Post 2 as  
71 described under this section. The successor to such commissioner shall be elected at the  
72 general election held in November, 2026.

73 (5) The initial member of the board from District 3 as newly described under this section  
74 shall be elected at the general election held in November, 2024. The commissioner  
75 elected at such election shall serve a four-year term of office.

76 **SECTION 2.**

77 Those members of the Board of Commissioners of Echols County who are serving as such  
78 on the effective date of this Act and any person selected to fill a vacancy in any such office  
79 shall continue to serve as such members until the regular expiration of their respective terms  
80 of office and upon the election and qualification of their respective successors.

81 **SECTION 3.**

82 The provisions of this Act necessary to conduct elections for the members of the Board of  
83 Commissioners of Echols County in 2024 shall become effective on January 1, 2024. The  
84 remaining provisions of this Act shall become effective on January 1, 2025.

85 **SECTION 4.**

86 All laws and parts of laws in conflict with this Act are repealed.
