

The House Committee on Intragovernmental Coordination - Local Legislation offers the following substitute to SB 560:

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act to create and establish in DeKalb County, Georgia, districts from which  
2 the members of the County Board of Education of DeKalb County shall be elected, approved  
3 April 12, 1963 (Ga. L. 1963, p. 3424), as amended, so as to revise provisions relating to the  
4 compensation of the board; to require the board to adopt procedures for the administration  
5 of expense accounts of the chairperson and board members; to provide for related matters;  
6 to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act to create and establish in DeKalb County, Georgia, districts from which the members  
10 of the County Board of Education of DeKalb County shall be elected, approved  
11 April 12, 1963 (Ga. L. 1963, p. 3424), as amended, is amended by revising Section 9 as  
12 follows:

13 "SECTION 9.

14 (a)(1) The chairperson of the board shall receive \$24,500.00 per annum as full

15 compensation for his or her duties on the board. Such compensation shall be paid in  
16 equal monthly installments from the funds of the board.

17 (2) The vice-chairperson of the board shall receive \$23,500.00 per annum as full  
18 compensation for his or her duties on the board. Such compensation shall be paid in  
19 equal monthly installments from the funds of the board.

20 (3) Each member of the board, other than the chairperson and vice-chairperson, shall  
21 receive \$22,500.00 per annum as full compensation for his or her duties on the board.  
22 Such compensation shall be paid to each member in equal monthly installments from the  
23 funds of the board.

24 (b)(1) In addition to the salary provided in subsection (a) of this section, the chairperson  
25 of the board shall receive an expense allowance of \$2,500.00 per annum.

26 (2) In addition to the salary provided in subsection (a) of this section, each member of  
27 the board shall receive an expense allowance of \$2,500.00 per annum.

28 (3) The expense accounts provided for in paragraphs (1) and (2) of this subsection shall  
29 only be used to reimburse actual expenses incurred by the chairperson and board  
30 members in their official capacity serving on the board. Prior to any reimbursements  
31 being made from such expense accounts, the board shall develop and adopt a policy  
32 governing which expenses are eligible for reimbursement, the procedures by which the  
33 chairperson or a board member can request reimbursement, and the procedure by which  
34 the school district and the board shall evaluate and approve such reimbursements."

## **SECTION 2.**

36 All laws and parts of laws in conflict with this Act are repealed.
