

The House Committee on Intragovernmental Coordination - Local Legislation offers the following substitute to SB 321:

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act providing for the compensation of certain county officers and officials of
2 DeKalb County, approved March 31, 1976 (Ga. L. 1976, p. 3986), as amended, so as to
3 revise the compensation of certain judges, judicial officers, and county officers; to provide
4 for an effective date; to repeal conflicting laws; and for other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 **SECTION 1.**

7 An Act providing for the compensation of certain county officers and officials of DeKalb
8 County, approved March 31, 1976 (Ga. L. 1976, p. 3986), as amended, is amended by
9 revising Sections 2 and 2.1 and adding a new subsection to read as follows:

10 "SECTION 1.1A

11 In addition to any compensation provided for in an Act providing a supplement to the
12 compensation, expenses, and allowances of the judges of the superior court of the Stone
13 Mountain Judicial Circuit, approved March 21, 1974 (Ga. L. 1974, p. 391), as amended,
14 beginning July 1, 2022, the salary supplement provided by DeKalb County to the superior

15 court judges of the Stone Mountain Judicial Circuit shall be increased in the amount of
16 \$21,489.00.

17 SECTION 2.

18 Notwithstanding any other provisions of law to the contrary, the annual salary of each of
19 the officials of DeKalb County listed below shall be the following percentages of the gross
20 salary as defined in Section 1:

- 21 (1) Judge of the Probate Court.....90%
- 22 (2) Clerk of the Superior Court.....75%
- 23 (3) Tax Commissioner.....75%
- 24 (4) Judge of the Juvenile Court.....90%

25 SECTION 2.1.

26 Notwithstanding any other provisions of law to the contrary, the annual salary of each of
27 the officials of DeKalb County listed below shall be the following percentages of the gross
28 salary as defined in Section 1:

- 29 (1) Chief Executive Officer.....100%
- 30 (2) Members of the Board of Commissioners.....31.984326641319%"

31 SECTION 2.

32 Said Act is further amended by revising Section 3 as follows:

33 "SECTION 3.

34 Notwithstanding any other provisions of law to the contrary, the annual salary of each of
35 the officials of DeKalb County listed below shall be the following percentages of the gross
36 salary as defined in Section 1:

- 37 (1) State Court Judge, Jury and Traffic Division.....90%

38	(2) State Court Solicitor.....	90%
39	(3) Chief Magistrate.....	90%
40	(4) Associate Magistrate.....	67.5%
41	(5) District Attorney.....	100%"

42 **SECTION 3.**

43 This Act shall become effective on July 1, 2022.

44 **SECTION 4.**

45 All laws and parts of laws in conflict with this Act are repealed.
