A BILL TO BE ENTITLED  
AN ACT

1 To amend Code Section 45-16-24 of the Official Code of Georgia Annotated, relating to  
2 notification of suspicious or unusual deaths, court ordered medical examiner's inquiry, and  
3 written report of inquiry, so as to revise the period for which an individual had not been seen  
4 by a physician prior to death to be considered an unattended death; to provide for related  
5 matters; to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 Code Section 45-16-24 of the Official Code of Georgia Annotated, relating to notification  
9 of suspicious or unusual deaths, court ordered medical examiner's inquiry, and written report  
10 of inquiry, is amended by revising subsection (a) as follows:

11 "(a) When any individual dies in any county in this state:

12 (1) As a result of violence;

13 (2) By suicide or casualty;

14 (3) Suddenly when in apparent good health;

15 (4) In any suspicious or unusual manner, with particular attention to those individuals  
16 16 years of age and under;

17 (5) After birth but before seven years of age if the death is unexpected or unexplained;

- 18 (6) As a result of an execution carried out pursuant to the imposition of the death penalty  
19 under Article 2 of Chapter 10 of Title 17;
- 20 (7) When an inmate of a state hospital or a state, county, or city penal institution;
- 21 (8) After having been admitted to a hospital in an unconscious state and without  
22 regaining consciousness within 24 hours of admission;
- 23 (9) As a result of an apparent drug overdose;
- 24 (10) Who is a pregnant female or a female who was pregnant within 365 days prior to  
25 such female's death; provided, however, that this paragraph shall not apply to a female  
26 whose death resulted from an incidental or accidental cause, including a motor vehicle  
27 accident, or from any other event or condition where it is apparent that the death was not  
28 causally related to the care of or physiology of pregnancy or its maintenance; or
- 29 (11) When unattended by a physician,  
30 it shall be the duty of any law enforcement officer or other person having knowledge of  
31 such death to notify immediately the coroner or county medical examiner of the county in  
32 which the acts or events resulting in the death occurred or the body is found. For purposes  
33 of paragraph (11) of this subsection, no individual shall be deemed to have died unattended  
34 by a physician when the death occurred while he or she was a patient of a hospice licensed  
35 under Article 9 of Chapter 7 of Title 31. For purposes of paragraph (11) of this subsection,  
36 an individual shall be deemed to have died unattended by a physician when any such  
37 individual had not been seen or treated by a physician within the ~~180~~ 60 days prior to such  
38 individual's death for a condition or illness likely to have caused or contributed to such  
39 individual's death."

**SECTION 2.**

41 All laws and parts of laws in conflict with this Act are repealed.
