## A RESOLUTION

1 Dedicating certain portions of the state highway system; and for other purposes.

40 late Lloyd Rogers and Ethel Oliver Rogers on July 5, 1940, and was called home to be with  
41 the Lord on March 27, 2022; and

42 WHEREAS, Jerry and Frances met and fell in love at Berry College in Rome, Georgia,  
43 married on August 26, 1961, and built their lives together and raised a family encompassing  
44 six children, 14 grandchildren, and growing numbers of great-grandchildren; and

45 WHEREAS, from 1966 and thereafter, Jerry and Frances raised their family in the same  
46 home on Lakewood Drive until their passings and played important roles in their community  
47 and in their church, the Gospel Light Baptist Tabernacle; and

48 WHEREAS, Jerry began his career as a school teacher along with Frances before moving  
49 back to Cobb County to join the manufacturing industry, culminating in almost 25 years  
50 working for Lockheed Martin in Marietta supporting the production of C-130s; and

51 WHEREAS, Frances's passion was for education and children which was demonstrated by  
52 her calling to be an elementary school teacher with over 20 years of service at four schools:  
53 Coosa Elementary, Johnson Elementary, Lockheed Elementary, and Marietta Christian  
54 School; and

55 WHEREAS, Frances never stopped being an educator, with a great sense of dry humor, to  
56 the young and the old until the day she left this world; and

57 WHEREAS, Jerry and Frances made youth baseball and sports a family endeavor, making  
58 Adams Park in Kennesaw a second home with five children cycling through the park for over  
59 two decades; and

60 WHEREAS, Jerry inspired leadership traits in his children through taking on various roles  
61 including coach, umpire, and president of the Kennesaw Baseball Association; and

62 WHEREAS, Jerry, a deacon, and Frances, a Sunday school teacher, were anchored by their  
63 faith and called to serve family, friends, and strangers by opening up their home and offering  
64 their resources to those in need for over 45 years; and

65 WHEREAS, it is abundantly fitting and proper that these remarkable and distinguished  
66 Georgians be appropriately recognized by dedicating an intersection in their memory.

72 Dr. Morrow was the CEO of Morrow Family Medicine, a state of the art family practice in  
73 Cumming, Georgia, for ten years, where he was adored by his staff as a mentor, a friend, and  
74 a trusted physician and earned the titles of the "Top 25 Place to Work in Atlanta" and the  
75 "Best in Forsyth" in family medicine; and

76 WHEREAS, Dr. Morrow's leadership was invaluable to organizations such as the  
77 Certification Commission for Healthcare Information Technology and the Health  
78 Information Management and Systems Society (HIMSS); and

79 WHEREAS, his talent was recognized with numerous honors and awards, including the 2014  
80 Steve Bloom Entrepreneur of the Year by the Cumming Forsyth Chamber of Commerce, the  
81 Phoenix Award as Community Leader of the Year from the Metro Atlanta Chamber of  
82 Commerce, the HIMSS Primary Care Davies Award, the HIMSS Physician IT Leader of the

94 as Dr. Martin Luther King, Jr., Vernon Jordan, Jesse Hill, Herman Russell, Maynard Jackson,  
95 Walt Frazier, Ambassador Andrew Young, and countless others; and

96 WHEREAS, his contributions to the community were recognized in 1995 when the Butler  
97 Street YMCA constructed a new branch and named the facility the J.D. Winston YMCA; and

98 WHEREAS, a man of deep and abiding faith, Mr. Winston was an active and faithful  
99 member of the Second Mt. Zion Baptist Church, where he served in numerous capacities,  
100 including as a Sunday school teacher; and

101 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished  
102 Georgian be appropriately recognized by dedicating an intersection in his memory.

104 WHEREAS, Kristi Jayne, Karolyn "Karri" Marie, and Tabbatha Rene' Lawhorne passed  
105 away in a tragic car accident on May 17, 1998; and

106 WHEREAS, Kristi Jayne Lawhorne was born on May 16, 1980, and was a cheerleader,  
107 cross-country runner, and a budding actress; and

108 WHEREAS, Kristi Jayne had a great love for Jesus and after her passing it was discovered  
109 that she had a list of over 100 people for whom she prayed daily; and

110 WHEREAS, Tabbatha Rene' Lawhorne was born in June 18, 1982, and was a standout soccer  
111 and softball player; and

112 WHEREAS, Tabbatha was a compassionate and generous soul, who went out of her way to  
113 help others in their time of need; and

114 WHEREAS, Karolyn "Karri" Marie Lawhorne was born on December 18, 1983, and was  
115 beautiful both inside and out; and

116 WHEREAS, Karri loved her family and friends fiercely and was known as the life of the  
117 party as a talented singer, star athlete, and an amazing artist; and

118 WHEREAS, it is abundantly fitting and proper that these remarkable and distinguished  
119 Georgians be recognized appropriately by dedicating an intersection in their memory.

121 WHEREAS, Mr. Michael Anthony Woodall was a dedicated and faithful public servant  
122 whose life was tragically cut short on June 15, 2023, during service as the District 3 assistant  
123 highway maintenance foreman with the Georgia Department of Transportation; and

124 WHEREAS, Mr. Woodall diligently and conscientiously devoted innumerable hours of his  
125 time, talents, and energy toward the betterment of his community and state as evidenced  
126 dramatically by his superlative service after numerous severe weather incidents in this state;  
127 and

128 WHEREAS, he played a vital role for the Georgia Department of Transportation and was  
129 known for his willingness to do whatever was necessary to ensure roads in this state were  
130 clear and safe for travel; and

131 WHEREAS, Mr. Woodall began his career with the department in 2018 as an equipment  
132 operator and worked his way up to assistant foreman in Columbus; and

133 WHEREAS, he was known by his colleagues and others as a very kind and generous person  
134 who was always willing to help and who never once hesitated when performing his job  
135 duties; and

136 WHEREAS, Mr. Woodall will always be remembered for his love of the outdoors, the  
137 Georgia Bulldogs, and his unyielding commitment that set the standard for public service;  
138 and

139 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished  
140 Georgian be appropriately recognized by dedicating an intersection in his memory.

142 WHEREAS, Mr. George R. Eusner was raised in Monticello, New York, and graduated from  
143 Virginia Polytechnic Institute in 1942; and

144 WHEREAS, his work transformed the refractory industry, as the vice president of the  
145 refractories and mineral technologies division at U.S. Steel and executive vice president of  
146 Davis Fire Brick Company; and

147 WHEREAS, in 1964, Mr. Eusner saw a need for calcined mullite for the refractory market,  
148 which led him to Andersonville, Georgia, where local raw materials were available through  
149 the Georgia Kaolin Company, and he joined forces with Mr. Lewis Eastern, mayor of  
150 Andersonville, to build a small plant that could produce 50 tons per week of high-quality  
151 calcine mullite; and

152 WHEREAS, he founded Mullite Company of America shortly thereafter, which became a  
153 major player in the industry known for its innovative technology and commitment to quality,

154 and it continues to make a positive economic impact for Sumter, Schley, and Macon  
155 counties; and

156 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished  
157 Georgian be recognized appropriately by dedicating a bridge in his memory.

160 WHEREAS, our nation's security continues to rely on patriotic men and women who put  
161 their personal lives on hold in order to place themselves in harm's way to protect the  
162 freedoms that all United States citizens cherish; and

163 WHEREAS, Corporal Dewey E. Rewis, Jr., was a guardian of this nation's freedom and  
164 liberty with the United States Army, serving in the Korean War; and

165 WHEREAS, Corporal Rewis was reported missing in action on December 2, 1950, after his  
166 unit came under attack during an advance along the eastern banks of the Chosin Reservoir  
167 in North Korea; and

168 WHEREAS, it was reported that Corporal Rewis was held as a prisoner of war and died in  
169 an area called the Death Valley, which served as a collection point for United Nations  
170 prisoners, but his remains were not returned home to his family and accounted for until  
171 October 25, 2022; and

172 WHEREAS, Corporal Rewis demonstrated selfless service to this nation and his unyielding  
173 commitment to protecting the people and ideals of the United States in giving the ultimate  
174 sacrifice will be remembered always; and

175 WHEREAS, he embodied the spirit of service, willing to find meaning in something greater  
176 than himself and it is abundantly fitting and proper that this remarkable and distinguished

186 United Detective Agency, where he earned a well deserved reputation for getting results for  
187 his clients; and

188 WHEREAS, he provided security detail for the stars and sets of several movies filmed in  
189 Savannah and went on to co-produce films and television programs with Burt Reynolds  
190 through their production company, Sun Classic Pictures; and

191 WHEREAS, later in life, Mr. Liakakis worked in politics as a campaign manager and adviser  
192 before running for office himself in 1995 at age 63, when he was elected as alderman at large  
193 for the Savannah City Council; and

194 WHEREAS, he later served on the Chatham County Board of Commissioners as chairman  
195 and held leadership roles for the Chatham Area Transit Authority, the executive committee

196 of the American Cancer Society, Savannah Tech Foundation, and the Beach Institute, to  
197 name just a few; and

198 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished  
199 Georgian be recognized appropriately by dedicating a road in his memory.

209 WHEREAS, Mrs. Johnson's significant organizational and leadership talents, her remarkable

211 citizens of this state earned her the respect and admiration of her colleagues and associates;  
212 and

213 WHEREAS, she was a person of magnanimous strengths with an unimpeachable reputation

215 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished

225 his blind mother passed away, yet he went on to earn a bachelor's degree in chemistry from  
226 Morris Brown College, earn a Purple Heart for his heroic service during World War II, and  
227 become a renowned research chemist with the United States Department of Agriculture; and

228 WHEREAS, Rep. Juanita Williams graduated third in her class at Savannah State College  
229 and earned a master's degree from Atlanta University; and

230 WHEREAS, she was elected to the Georgia House of Representatives in 1984 and diligently  
231 and conscientiously devoted innumerable hours of her time, talents, and energy toward the  
232 betterment of her community and state for four terms; and

233 WHEREAS, following the teachings of Dr. Martin Luther King, Jr., to "clothe the naked and  
234 feed the hungry," Rev. Dr. and Rep. Williams founded the Hosea Feed the Hungry and

246 WHEREAS, the Thomas family roots in Forsyth County run deep, with the family's origins

249 providing customers with the highest quality lumber products in pine, cypress, Brazilian
