## A RESOLUTION

1 Recognizing and commending Richard L. Jackson, recipient of the 2025 Leaders in  
2 Corporate Citizenship Ann Cramer Lifetime Achievement Award; and for other purposes.

3 WHEREAS, Richard L. Jackson currently serves as the founder, chairman, and CEO of  
4 Jackson Healthcare, one of the largest healthcare staffing companies in the United States,  
5 where he has been instrumental in conceptualizing and developing more than 30 healthcare  
6 companies; and

7 WHEREAS, he was selected recently by the *Atlanta Business Chronicle* as the recipient of  
8 the 2025 Leaders in Corporate Citizenship Ann Cramer Lifetime Achievement Award in  
9 honor of the positive impact he has made on people and communities throughout his career;

11 WHEREAS, the Ann Cramer Lifetime Achievement Award, the program's highest honor,  
12 celebrates outstanding corporate citizens who have achieved a lifetime of service to the  
13 community; and

14 WHEREAS, in addition to Jackson Healthcare, he further serves as founder of Fostering  
15 Success Act Inc., a nonprofit dedicated to providing vital resources for young people aging

16 out of Georgia's foster care system, and as co-founder and chair of FaithBridge Foster Care,  
17 Georgia's largest private child-placing agency; and

18 WHEREAS, in 2024, Fostering Success Act Inc. delivered \$4 million in financial support  
19 to former foster youth pursuing post-secondary education, and since its inception in 2009,  
20 FaithBridge has positively impacted nearly 2,000 children and facilitated more than 1,000  
21 family reunifications and over 350 adoptions; and

22 WHEREAS, Richard L. Jackson's significant organizational and leadership talents,  
23 remarkable patience and diplomacy, keen sense of vision, and sensitivity to the needs of the  
24 citizens of this state have earned him the respect and admiration of his colleagues and  
25 associates; and

26 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this  
27 remarkable and distinguished individual be appropriately honored during this special time.

28 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that  
29 the members of this body recognize and commend Richard L. Jackson, recipient of the 2025
