## A RESOLUTION

1 Recognizing and commending Karen Ramsey; and for other purposes.

2 WHEREAS, Karen Ramsey has long been recognized by the citizens of this state for the vital  
3 role that she has played in leadership and her deep personal commitment to the welfare of  
4 the citizens of Georgia; and

5 WHEREAS, she has diligently and conscientiously devoted innumerable hours of her time,  
6 talents, and energy toward the betterment of her community and state as evidenced  
7 dramatically by her superlative service as the Deputy Director of Gwinnett Housing  
8 Corporation (GHC); and

9 WHEREAS, since joining GHC in 2022, Karen has made significant impact, including the  
10 launch of the Homeowner Resource Center, the Healthy Homes Production Program, and  
11 the Older Adults Home Modification Program; and

12 WHEREAS, the Homeowner Resource Center, which is the first of its kind in Gwinnett  
13 County, provides resources, education, and services for current and aspiring homeowners  
14 with a focus on low to moderate income households; and

15 WHEREAS, the Healthy Homes Production Program provides no cost home hazard testing  
16 and home repairs for low to moderate income Gwinnett County homeowners and renters; and

17 WHEREAS, through the Older Adults Home Modification Program, Gwinnett Housing  
18 Corporation has been able to provide low-cost, high-impact home modifications for Gwinnett  
19 County senior citizens to help them safely age in place and remain in their homes; and

20 WHEREAS, as a testament to her dedication and compassion, Karen was elected to serve on  
21 the 2025 Balance of State COC Board of Directors Super Region Representatives for Region  
22 2; and

23 WHEREAS, Karen's significant organizational and leadership talents, remarkable patience  
24 and diplomacy, keen sense of vision, and sensitivity to the needs of the citizens of this state  
25 have earned her the respect and admiration of her colleagues and associates; and

26 WHEREAS, she is a person of magnanimous strengths with an unimpeachable reputation for  
27 integrity, intelligence, fairness, and kindness; and

28 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this  
29 remarkable and distinguished Georgian be appropriately recognized.
