## A RESOLUTION

1 Recognizing and commending the State Government Affairs Council upon its 50th  
2 anniversary; and for other purposes.

5 community and relationship building with peers and elected officials, building knowledge,

23 government relations.

24 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that  
25 the members of this body recognize and commend the State Government Affairs Council for  
26 its 50 years of dedicated service and significant contributions to enhancing the relationship  
27 between state and local governments, businesses, and communities.
