**AS PASSED SENATE**

A BILL TO BE ENTITLED

AN ACT

1 To amend an Act revising, superseding, and consolidating the laws relating to the governing  
 2 authority of DeKalb County and creating a chairman and board of commissioners of said  
 3 county, approved March 8, 1956 (Ga. L. 1956, p. 3237), as amended, particularly by an Act  
 4 approved April 9, 1981 (Ga. L. 1981, p. 4304), an Act approved March 20, 1990  
 5 (Ga. L. 1990, p. 3900), an Act approved April 13, 1992 (Ga. L. 1992, p. 6137), an Act  
 6 approved May 12, 2015 (Ga. L. 2015, p. 3811), and an Act approved July 29, 2020  
 7 (Ga. L. 2020, p. 4069), so as to revise administrative procedures related to verification of  
 8 ethics complaints; to provide for related matters; to repeal conflicting laws; and for other  
 9 purposes.

10 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

11 **SECTION 1.**

12 An Act revising, superseding, and consolidating the laws relating to the governing authority  
 13 of DeKalb County and creating a chairman and board of commissioners of said county,  
 14 approved March 8, 1956 (Ga. L. 1956, p. 3237), as amended, particularly by an Act approved  
 15 April 9, 1981 (Ga. L. 1981, p. 4304), an Act approved March 20, 1990 (Ga. L. 1990,  
 16 p. 3900), an Act approved April 13, 1992 (Ga. L. 1992, p. 6137), an Act approved

17 May 12, 2015 (Ga. L. 2015, p. 3811), and an Act approved July 29, 2020 (Ga. L. 2020,  
18 p. 4069), is amended by revising subparagraph (f)(1)(B) of Section 22A as follows:

19 "(B) A sworn written complaint may be filed with the ethics administrator of the Board  
20 of Ethics, as described in this paragraph. All written complaints to be considered by  
21 the Board of Ethics and the ethics administrator shall contain the following, if  
22 applicable:

- 23 (i) The name and address of the person or persons filing the complaint;  
24 (ii) The signature of the complainant which shall be validated by the ethics officer;  
25 (iii) The name and address of the party or parties against whom the complaint is filed  
26 and, if such party is a candidate, the office being sought;  
27 (iv) A clear and concise statement of acts upon which the complaint is based along  
28 with an allegation that such facts constitute one or more violations of law under the  
29 jurisdiction of the Board of Ethics;  
30 (v) A general reference to the allegedly violated statutory provision(s) of the code of  
31 ethics within the jurisdiction of the Board of Ethics; and  
32 (vi) Any further information which might support the allegations in the complaint  
33 including, but not limited to, the following:  
34 (I) The names and addresses of all other persons who have firsthand knowledge of  
35 the facts alleged in the complaint; and  
36 (II) Any documentary evidence that supports the facts alleged in the complaint;"

37 **SECTION 2.**

38 Said Act is further amended by revising paragraph (3) of subsection (j) of Section 22A as  
39 follows:

40 "(3) A complaint may be filed by any resident or group of residents of DeKalb County  
41 by submitting to the office of the ethics administrator a written, and sworn complaint  
42 under the penalty of perjury or false swearing. The complaint shall specifically identify

43 all provisions of the DeKalb County code of ethics which the subject of the complaint is  
44 alleged to have violated, set forth facts as would be admissible in evidence in a court  
45 proceeding, and show affirmatively that the complainant or affiant (if in addition to or  
46 different from the complainant) is competent to testify to the matter set forth therein. All  
47 documents referenced in the complaint as well as supporting affidavits shall be attached  
48 to the complaint;"

**SECTION 3.**

50 All laws and parts of laws in conflict with this Act are repealed.
