20 schools, while working to provide the very best opportunities, experiences, and support for

22 WHEREAS, he is a person of magnanimous strengths with an unimpeachable reputation for
23 integrity, intelligence, fairness, and kindness; and

24 WHEREAS, Mr. Carnaroli has served with honor and distinction with Forsyth County
25 Schools, and his vision and unyielding commitment to student success will be sorely missed
26 upon the occasion of his retirement; and

27 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this
28 remarkable and distinguished Georgian be appropriately recognized.
