A RESOLUTION

1 Dedicating certain portions of the state highway system; and for other purposes.

PART I

3 WHEREAS, the dedication of the Dr. Robert F. Sullivan Memorial Highway was sponsored
4 by Senator Bo Hatchett as SR 583 in the 2024 Session; and

5 WHEREAS, Dr. Robert F. Sullivan has long been recognized by the citizens of this state for
6 the vital role that he has played in leadership and his deep personal commitment to the
7 welfare of the citizens of Georgia; and

8 WHEREAS, Dr. Sullivan was born on September 21, 1927, the beloved son of Franklin
9 Clyde and Minnie Valdivia "Dee" Gillespie Sullivan and served as a guardian of this nation's
10 freedom and liberty with the United States Navy during the Korean War; and

11 WHEREAS, Dr. Sullivan earned his medical degree from Emory University, began his
12 medical practice in Carnesville, Georgia, in 1957, and served as chief of staff for Cobb
13 Memorial Hospital in Royston, Georgia; and

14 WHEREAS, he diligently and conscientiously devoted innumerable hours of his time,
15 talents, and energy toward the betterment of his community and state as evidenced
16 dramatically by his superlative service as president of the Carnesville Lions Club; and

17 WHEREAS, a man of deep and abiding faith, Dr. Sullivan was a lifelong member of
18 Carnesville Methodist Church; and

19 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
20 Georgian be recognized appropriately by dedicating a road in his memory.

22 WHEREAS, the dedication of the Lary Jack Moree Memorial Bridge was sponsored by
23 Senator Sam Watson as SR 612 in the 2024 Session; and

24 WHEREAS, Mr. Lary Jack Moree has long been recognized by the citizens of this state for
25 the vital role that he played in leadership and his deep personal commitment to the welfare
26 of the citizens of Georgia; and

27 WHEREAS, Mr. Moree was born on November 9, 1942, the beloved son of R.V. and Miltie
28 Jeanette Johnson Moree and was the owner and operator of Moree's Grocery and Liquor
29 Store, the family business he took over from his father; and

30 WHEREAS, an avid golfer, Mr. Moree gave inspiration to many through his high ideals,
31 morals, and deep concern for his fellow citizens; and

32 WHEREAS, the devotion, patience, and understanding Mr. Moree demonstrated to his
33 family and friends were admired by others; and

34 WHEREAS, he was a person of magnanimous strengths with an unimpeachable reputation
35 for integrity, intelligence, fairness, and kindness, and by the example he made of his life, he
36 made this world a better place in which to live; and

37 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
38 Georgian be recognized appropriately by dedicating a bridge in his memory.

40 WHEREAS, the dedication of the "Coach" Jerry L. Waller, Sr., and Frances R. Waller
41 Memorial Intersection was sponsored by Senator Steve Gooch as SR 633 in the 2024
42 Session; and

43 WHEREAS, Jerry Lee Waller, Sr., was born in Cobb County to the late Gordon Lee Waller
44 and Frances Ocille Smith Waller on March 12, 1938, and was called home to be with the
45 Lord on September 13, 2006; and

46 WHEREAS, Mary Frances Rogers Waller, who went by Frances, was born in Cohutta to the
47 late Lloyd Rogers and Ethel Oliver Rogers on July 5, 1940, and was called home to be with
48 the Lord on March 27, 2022; and

49 WHEREAS, Jerry and Frances met and fell in love at Berry College in Rome, Georgia,
50 married on August 26, 1961, and built their lives together and raised a family encompassing
51 six children, 14 grandchildren, and growing numbers of great-grandchildren; and

52 WHEREAS, from 1966 and thereafter, Jerry and Frances raised their family in the same
53 home on Lakewood Drive until their passings and played important roles in their community
54 and in their church, the Gospel Light Baptist Tabernacle; and

55 WHEREAS, Jerry began his career as a school teacher along with Frances before moving
56 back to Cobb County to join the manufacturing industry, culminating in almost 25 years
57 working for Lockheed Martin in Marietta supporting the production of C-130s; and

58 WHEREAS, Frances's passion was for education and children which was demonstrated by
59 her calling to be an elementary school teacher with over 20 years of service at four schools:
60 Coosa Elementary, Johnson Elementary, Lockheed Elementary, and Marietta Christian
61 School; and

62 WHEREAS, Frances never stopped being an educator, with a great sense of dry humor, to
63 the young and the old until the day she left this world; and

64 WHEREAS, Jerry and Frances made youth baseball and sports a family endeavor, making
65 Adams Park in Kennesaw a second home with five children cycling through the park for over
66 two decades; and

67 WHEREAS, Jerry inspired leadership traits in his children through taking on various roles
68 including coach, umpire, and president of the Kennesaw Baseball Association; and

69 WHEREAS, Jerry, a deacon, and Frances, a Sunday school teacher, were anchored by their
70 faith and called to serve family, friends, and strangers by opening up their home and offering
71 their resources to those in need for over 45 years; and

72 WHEREAS, it is abundantly fitting and proper that these remarkable and distinguished
73 Georgians be appropriately recognized by dedicating an intersection in their memory.

75 WHEREAS, the dedication of the Dr. Jim Morrow Memorial Intersection was sponsored by
76 Senator Greg Dolezal as SR 631 in the 2024 Session; and

77 WHEREAS, Dr. Jim Morrow dedicated 43 years to providing compassionate care as a family
78 medicine physician, a gifted diagnostician, and a beloved friend to his patients and
79 colleagues; and

80 WHEREAS, a graduate of Clemson University and the University of South Carolina,
81 Dr. Morrow was the CEO of Morrow Family Medicine, a state of the art family practice in
82 Cumming, Georgia, for ten years, where he was adored by his staff as a mentor, a friend, and
83 a trusted physician and earned the titles of the "Top 25 Place to Work in Atlanta" and the
84 "Best in Forsyth" in family medicine; and

85 WHEREAS, Dr. Morrow's leadership was invaluable to organizations such as the
86 Certification Commission for Healthcare Information Technology and the Health
87 Information Management and Systems Society (HIMSS); and

88 WHEREAS, his talent was recognized with numerous honors and awards, including the 2014
89 Steve Bloom Entrepreneur of the Year by the Cumming Forsyth Chamber of Commerce, the
90 Phoenix Award as Community Leader of the Year from the Metro Atlanta Chamber of
91 Commerce, the HIMSS Primary Care Davies Award, the HIMSS Physician IT Leader of the
92 Year, and the Distinguished Humanitarian Physician Alumni of the Year Award from the
93 University of South Carolina School of Medicine; and

94 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
95 Georgian be appropriately recognized by dedicating an intersection in his memory.

97 WHEREAS, the dedication of the Mr. Joseph Donald "J.D." Winston Memorial Intersection
98 was sponsored by Senator Nan Orrock as SR 774 in the 2024 Session; and

99 WHEREAS, Mr. Joseph Donald "J.D." Winston was born on March 30, 1915, in Lanette,
100 Alabama, the youngest of 11 siblings born to Hope and Mary Winston; and

101 WHEREAS, a graduate of Washington High School in Atlanta, Georgia, Mr. Winston
102 attended Clark College and dedicated his life to enriching and uplifting young children at the
103 historic Butler Street YMCA, which served as the only Black YMCA in the city; and

104 WHEREAS, while at the Butler Street YMCA, he served as a mentor to future leaders such
105 as Dr. Martin Luther King, Jr., Vernon Jordan, Jesse Hill, Herman Russell, Maynard Jackson,
106 Walt Frazier, Ambassador Andrew Young, and countless others; and

107 WHEREAS, his contributions to the community were recognized in 1995 when the Butler
108 Street YMCA constructed a new branch and named the facility the J.D. Winston YMCA; and

109 WHEREAS, a man of deep and abiding faith, Mr. Winston was an active and faithful
110 member of the Second Mt. Zion Baptist Church, where he served in numerous capacities,
111 including as a Sunday school teacher; and

112 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
113 Georgian be appropriately recognized by dedicating an intersection in his memory.

115 WHEREAS, the dedication of the Lawhorne Memorial Intersection was sponsored by
116 Representative Brent Cox as HR 1118 in the 2024 Session; and

117 WHEREAS, Kristi Jayne, Karolyn "Karri" Marie, and Tabbatha Rene' Lawhorne passed
118 away in a tragic car accident on May 17, 1998; and

119 WHEREAS, Kristi Jayne Lawhorne was born on May 16, 1980, and was a cheerleader,
120 cross-country runner, and a budding actress; and

121 WHEREAS, Kristi Jayne had a great love for Jesus and after her passing it was discovered
122 that she had a list of over 100 people for whom she prayed daily; and

123 WHEREAS, Tabbatha Rene' Lawhorne was born in June 18, 1982, and was a standout soccer
124 and softball player; and

125 WHEREAS, Tabbatha was a compassionate and generous soul, who went out of her way to
126 help others in their time of need; and

127 WHEREAS, Karolyn "Karri" Marie Lawhorne was born on December 18, 1983, and was
128 beautiful both inside and out; and

129 WHEREAS, Karri loved her family and friends fiercely and was known as the life of the
130 party as a talented singer, star athlete, and an amazing artist; and

131 WHEREAS, it is abundantly fitting and proper that these remarkable and distinguished
132 Georgians be recognized appropriately by dedicating an intersection in their memory.

134 WHEREAS, the dedication of the Michael Anthony Woodall Memorial Intersection was
135 sponsored by Representative Patty Marie Stinson as HR 1162 in the 2024 Session; and

136 WHEREAS, Mr. Michael Anthony Woodall was a dedicated and faithful public servant
137 whose life was tragically cut short on June 15, 2023, during service as the District 3 assistant
138 highway maintenance foreman with the Georgia Department of Transportation; and

139 WHEREAS, Mr. Woodall diligently and conscientiously devoted innumerable hours of his
140 time, talents, and energy toward the betterment of his community and state as evidenced
141 dramatically by his superlative service after numerous severe weather incidents in this state;
142 and

143 WHEREAS, he played a vital role for the Georgia Department of Transportation and was
144 known for his willingness to do whatever was necessary to ensure roads in this state were
145 clear and safe for travel; and

146 WHEREAS, Mr. Woodall began his career with the department in 2018 as an equipment
147 operator and worked his way up to assistant foreman in Columbus; and

148 WHEREAS, he was known by his colleagues and others as a very kind and generous person
149 who was always willing to help and who never once hesitated when performing his job
150 duties; and

151 WHEREAS, Mr. Woodall will always be remembered for his love of the outdoors, the
152 Georgia Bulldogs, and his unyielding commitment that set the standard for public service;
153 and

154 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
155 Georgian be appropriately recognized by dedicating an intersection in his memory.

157 WHEREAS, the dedication of the George R. Eusner Memorial Bridge was sponsored by
158 Representative Patty Marie Stinson as HR 1227 in the 2024 Session; and

159 WHEREAS, Mr. George R. Eusner was raised in Monticello, New York, and graduated from
160 Virginia Polytechnic Institute in 1942; and

161 WHEREAS, his work transformed the refractory industry, as the vice president of the
162 refractories and mineral technologies division at U.S. Steel and executive vice president of
163 Davis Fire Brick Company; and

164 WHEREAS, in 1964, Mr. Eusner saw a need for calcined mullite for the refractory market,
165 which led him to Andersonville, Georgia, where local raw materials were available through
166 the Georgia Kaolin Company, and he joined forces with Mr. Lewis Eastern, mayor of
167 Andersonville, to build a small plant that could produce 50 tons per week of high-quality
168 calcine mullite; and

169 WHEREAS, he founded Mullite Company of America shortly thereafter, which became a
170 major player in the industry known for its innovative technology and commitment to quality,
171 and it continues to make a positive economic impact for Sumter, Schley, and Macon
172 counties; and

173 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
174 Georgian be recognized appropriately by dedicating a bridge in his memory.

PART IX

176 WHEREAS, the dedication of the US Army Cpl. Dewey E. Lewis Jr., Memorial Bridge was
177 sponsored by Representative John Corbett as HR 1228 in the 2024 Session; and

178 WHEREAS, our nation's security continues to rely on patriotic men and women who put
179 their personal lives on hold in order to place themselves in harm's way to protect the
180 freedoms that all United States citizens cherish; and

181 WHEREAS, Corporal Dewey E. Rewis, Jr., was a guardian of this nation's freedom and
182 liberty with the United States Army, serving in the Korean War; and

183 WHEREAS, Corporal Rewis was reported missing in action on December 2, 1950, after his
184 unit came under attack during an advance along the eastern banks of the Chosin Reservoir
185 in North Korea; and

186 WHEREAS, it was reported that Corporal Rewis was held as a prisoner of war and died in
187 an area called the Death Valley, which served as a collection point for United Nations
188 prisoners, but his remains were not returned home to his family and accounted for until
189 October 25, 2022; and

190 WHEREAS, Corporal Rewis demonstrated selfless service to this nation and his unyielding
191 commitment to protecting the people and ideals of the United States in giving the ultimate
192 sacrifice will be remembered always; and

193 WHEREAS, he embodied the spirit of service, willing to find meaning in something greater
194 than himself and it is abundantly fitting and proper that this remarkable and distinguished
195 Georgian be recognized appropriately by dedicating a bridge in his memory.

197 WHEREAS, the dedication of the Chairman Pete Liakakis Memorial Highway was
198 sponsored by Representative Carl Gilliard as HR 1250 in the 2024 Session; and

199 WHEREAS, Mr. Peter "Pete" Liakakis was born on January 9, 1932, in Savannah, Georgia,
200 and attended Savannah High School; and

201 WHEREAS, he served as a guardian of this nation's freedom and liberty with the United
202 States Air Force, was trained as a bomb disposal expert, and worked as the deputy director
203 of civil defense during the Cold War Era and as a covert intelligence officer; and

204 WHEREAS, Mr. Liakakis operated several firework retail stores in Savannah and a small
205 chain of Pal Convenience Stores before founding the United Security Agency and later the
206 United Detective Agency, where he earned a well deserved reputation for getting results for
207 his clients; and

208 WHEREAS, he provided security detail for the stars and sets of several movies filmed in
209 Savannah and went on to co-produce films and television programs with Burt Reynolds
210 through their production company, Sun Classic Pictures; and

211 WHEREAS, later in life, Mr. Liakakis worked in politics as a campaign manager and adviser
212 before running for office himself in 1995 at age 63, when he was elected as alderman at large
213 for the Savannah City Council; and

214 WHEREAS, he later served on the Chatham County Board of Commissioners as chairman
215 and held leadership roles for the Chatham Area Transit Authority, the executive committee

216 of the American Cancer Society, Savannah Tech Foundation, and the Beach Institute, to
217 name just a few; and

218 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
219 Georgian be recognized appropriately by dedicating a road in his memory.

221 WHEREAS, the dedication of the Frances Bright Johnson Memorial Interchange was
222 sponsored by Representative Carl Gilliard as HR 1251 in the 2024 Session; and

223 WHEREAS, Mrs. Frances Bright Johnson was born on April 17, 1937, the beloved daughter
224 of Robert Bryant, Sr., and Rosa Lee Williams; and

225 WHEREAS, Mrs. Johnson was raised in Garden City, Georgia, and graduated from Richard
226 Arnold High School; and

227 WHEREAS, an active leader of her community, Mrs. Johnson was a lifetime member of the
228 NAACP, served for ten years as chairperson of the Political Advisory Council, was a
229 member of the Chatham County Federation of Democratic Women, and was a member of
230 the YMCA and YWCA Executive Board Democratic Forum; and

231 WHEREAS, Mrs. Johnson's significant organizational and leadership talents, her remarkable
232 patience and diplomacy, her keen sense of vision, and her sensitivity to the needs of the
233 citizens of this state earned her the respect and admiration of her colleagues and associates;
234 and

235 WHEREAS, she was a person of magnanimous strengths with an unimpeachable reputation
236 for integrity, intelligence, fairness, and kindness; and

237 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
238 Georgian be recognized appropriately by dedicating an interchange in her memory.

PART XII

240 WHEREAS, the dedication of the Rev. Dr. Hosea Williams and Rep. Juanita T. Williams
241 Memorial Interchange was sponsored by Representative Carl Gilliard as HR 1253 in the
242 2024 Session; and

243 WHEREAS, Rev. Dr. Hosea L. Williams and Rep. Juanita T. Williams have long been
244 recognized by the citizens of this state for the vital roles that they have played in leadership
245 and their deep personal commitment to the welfare of the citizens of Georgia; and

246 WHEREAS, Rev. Dr. Hosea L. Williams was a renowned civil rights leader whose work was
247 crucial in achieving one of the civil rights movement's greatest accomplishments, the passage
248 of the 1964 Civil Rights Bill and the 1965 Voting Rights Act; and

249 WHEREAS, born on January 5, 1926, Rev. Dr. Williams was orphaned at the age of ten after
250 his blind mother passed away, yet he went on to earn a bachelor's degree in chemistry from
251 Morris Brown College, earn a Purple Heart for his heroic service during World War II, and
252 become a renowned research chemist with the United States Department of Agriculture; and

253 WHEREAS, Rep. Juanita Williams graduated third in her class at Savannah State College
254 and earned a master's degree from Atlanta University; and

255 WHEREAS, she was elected to the Georgia House of Representatives in 1984 and diligently
256 and conscientiously devoted innumerable hours of her time, talents, and energy toward the
257 betterment of her community and state for four terms; and

258 WHEREAS, following the teachings of Dr. Martin Luther King, Jr., to "clothe the naked and
259 feed the hungry," Rev. Dr. and Rep. Williams founded the Hosea Feed the Hungry and
260 Homeless aid organization in 1970, which is currently the largest direct-to-client food service
261 organization in the Southeast and a provider of medical and educational aid in Haiti and
262 Philippines; and

263 WHEREAS, it is abundantly fitting and proper that these remarkable and distinguished
264 Georgians be appropriately recognized by dedicating an interchange in their memory.

266 WHEREAS, the dedication of the Bobby Thomas Highway was sponsored by Representative
267 Lauren McDonald, III, as HR 1300 in the 2024 Session; and

268 WHEREAS, Mr. Bobby Thomas was born in 1946 in Cumming, Georgia, graduated from
269 Forsyth County High School, and earned a bachelor's degree from the Georgia Institute of
270 Technology; and

271 WHEREAS, he served as a guardian of this nation's freedom and liberty with the United
272 States Navy; and

273 WHEREAS, the Thomas family roots in Forsyth County run deep, with the family's origins
274 dating to before the Civil War and operating the Thomas Lumber Company since 1927; and

275 WHEREAS, as the current owner of Thomas Lumber Company, Mr. Thomas takes pride in
276 providing customers with the highest quality lumber products in pine, cypress, Brazilian
277 hardwood, and cedar; and

278 WHEREAS, Mr. Thomas' significant organizational and leadership talents have been
279 invaluable to numerous organizations, including the Cumming-Forsyth County Chamber of
280 Commerce, Rotary Club of Forsyth County, and the board of People's Bank of Forsyth
281 County; and

282 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
283 Georgian be appropriately recognized by dedicating a road in his honor.

285 WHEREAS, the dedication of the Jeff Downing Intersection was sponsored by
286 Representative Rick Jasperse as HR 1325 in the 2024 Session; and

287 WHEREAS, Mr. Jeff Downing has long been recognized by the citizens of Pickens County
288 and this state for the vital leadership role that he has played in his community and the
289 supermarket industry; and

290 WHEREAS, Mr. Downing began his grocery career in the tenth grade, working his way up
291 to leadership positions for Big Star Food Markets and A&P; and

292 WHEREAS, in 2002, Mr. Downing and his wife Sandy opened and operated Foothills IGA
293 in Marble Hill, Georgia, until his retirement in 2023; and

294 WHEREAS, Mr. Downing has earned many professional awards, including the IGA 2015
295 USA International Retailer of the Year award and the Georgia Food Industry Association's
296 2015 Legacy Award; and

297 WHEREAS, he has served in leadership positions in a number of philanthropic
298 organizations, including the Pickens County Chamber of Commerce, Good Samaritan Health
299 and Wellness Center, CARES food bank, Rotary Club, Hope House, Pickens Ferst
300 Foundation for Childhood Literacy, Georgia Food Industry Association, and the Georgia
301 Food Industry Education Foundation; and

302 WHEREAS, Mr. Downing was named 2014 Pickens County Citizen of the Year in honor of
303 his leadership and his service to the community; and

304 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
305 Georgian be appropriately recognized by dedicating an intersection in his honor.

307 WHEREAS, the dedication of the Maceo A. Brown Memorial Intersection was sponsored
308 by Representative Mesha Mainor as HR 1326 in the 2024 Session; and

309 WHEREAS, Mr. Maceo A. Brown was born in Atlanta, Georgia, and attended Henry McNeil
310 Turner High School; and

311 WHEREAS, he became a certified electrician in 1974 and began his own business, Maceo A.
312 Brown Electrical Contractors, which provides residential and commercial electrical services;
313 and

314 WHEREAS, Mr. Brown established System 5 Electronics, which provides residential and
315 commercial alarm system installation and monitoring; and

316 WHEREAS, in 2007, he founded MACEO's Kids, Inc., (Mentoring Aspiring CEO's), to
317 bring intelligent, compassionate, and dedicated members of the business community together
318 in pursuit of providing local youth with the opportunities and tools to grow as successful
319 members of society; and

320 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
321 Georgian be appropriately recognized by dedicating an intersection in his memory.

323 WHEREAS, the dedication of the Carolyn Long Banks Memorial Intersection was sponsored
324 by Representative Mesha Mainor as HR 1327 in the 2024 Session; and

325 WHEREAS, Mrs. Carolyn Lucille Long Banks was born on October 30, 1940, in Atlanta,
326 Georgia, the beloved daughter of Mr. Ralph A. Long, Sr., and Mrs. Rubye Carolyn Hall
327 Long; and

328 WHEREAS, a graduate of Turner High School, Mrs. Banks attended Clark College where
329 she became an active leader with the Atlanta Student Movement, which was a formidable
330 force for change and mobilized students for marches, sit ins, and boycotts for civil rights and
331 justice; and

332 WHEREAS, her leadership and dedication helped the Atlanta Student Movement see the
333 integration of local businesses and city facilities; and

334 WHEREAS, in 1980, Mrs. Banks became the first African American woman to serve on the
335 Atlanta City Council, where she spearheaded Atlanta's Proctor Creek Infrastructure Plan to
336 support African American communities and co-sponsored the Freedom Parkway
337 compromise; and

338 WHEREAS, she initiated a Children's Defense Fund partnership with cities across the nation
339 to improve youth civic engagement and served as president of the National League of Cities;
340 and

341 WHEREAS, Mrs. Banks was a member of the University of Georgia Municipal Leadership
342 Institute, Delta Sigma Theta Sorority, Inc., Leadership Atlanta, Atlanta Business League,
343 NAACP, National Coalition of 100 Black Women, and Southwest Cascade Garden Club; and

344 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
345 Georgian be appropriately recognized by dedicating an intersection in her memory.

347 WHEREAS, the dedication of the Douglas "Doug" H. Garrison Memorial Interchange was
348 sponsored by Representative Holt Persinger as HR 1328 in the 2024 Session; and

349 WHEREAS, the State of Georgia mourns the loss of one of its most distinguished citizens
350 with the passing of Mr. Douglas "Doug" H. Garrison on August 2, 2022; and

351 WHEREAS, Mr. Garrison graduated from the University of Georgia with a master's degree
352 in horticulture in 1971; and

353 WHEREAS, he diligently and conscientiously devoted innumerable hours of his time,
354 talents, and energy toward the betterment of his community and state as evidenced
355 dramatically by his superlative service with the County Extension Service, beginning with
356 Elbert County and later transferring to Barrow County; and
