

## Senate Resolution 534

## A RESOLUTION

1 Applauding Senator Brandon Beach for his exceptional service in the Georgia State Senate,  
2 his leadership in both public and private sectors, and congratulating him on his recent  
3 appointment as United States Treasurer in the current Trump Administration; and for other  
4 purposes.

5 WHEREAS, Senator Brandon Beach has served the people of Georgia with distinction for  
6 over two decades, having been elected to the Georgia State Senate in 2013 and currently  
7 serving as a Senator representing the 21st District, which includes parts of North Fulton and  
8 East Cobb counties; and

9 WHEREAS, Senator Beach has held several influential positions in the Senate, including his  
10 service as the Chairman of the Senate Transportation Committee, where he was instrumental  
11 in advancing transportation and infrastructure reforms critical to Georgia's economic growth  
12 and global competitiveness; and

13 WHEREAS, in addition to his work in transportation, Senator Beach served as Chairman of  
14 the Senate Economic Development and Tourism Committee, where he focused on fostering  
15 a business-friendly environment in Georgia; his work in this area included attracting major  
16 investments in key industries such as technology, entertainment, and manufacturing; and

19 further reflects his influence and leadership in shaping policy decisions that affect all parts

22 with a successful career in business, during which he has owned and operated multiple  
23 companies. He serves as the Executive Director and founder of the North Fulton  
24 Improvement District (NFCID) and has held key leadership roles, including serving on the  
25 boards of the Georgia Regional Transportation Authority (GRTA) and the Georgia  
26 Department of Transportation as well as Chair of the Public-Private Partnership Committee  
27 and the Land Development Committee; furthermore, he has served as Chairman of the Fulton  
28 County Development Authority; and

29 WHEREAS, Senator Beach's integrity, approach to problem-solving, and commitment to  
30 public service have earned him the respect and admiration of his colleagues and constituents,  
31 as well as recognition as a strong leader in Georgia politics; and

32 WHEREAS, Senator Beach's exemplary leadership and dedication to the people of Georgia  
33 were recognized on a national scale when he was appointed by President Donald J. Trump  
34 to serve as the United States Treasurer, a role in which he will carry significant responsibility  
35 for overseeing the nation's financial operations, managing the U.S. Mint and Fort Knox, and  
36 advising on matters of fiscal policy; and

37 WHEREAS, as the first Georgian to serve in this capacity, Senator Beach will continue to  
38 demonstrate the same commitment to public service, financial stewardship, and integrity that

39 defined his career in the Georgia State Senate, ensuring that federal fiscal policies serve the  
40 best interests of all Americans; and

41 WHEREAS, this prestigious appointment stands as a testament to Senator Beach's tireless  
42 dedication to the public good, his leadership in both state and national government, and his  
43 ongoing commitment to improving the financial systems that support the country's economy.

44 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body  
45 honor and applaud Senator Brandon Beach for his exceptional service to the State of  
46 Georgia, his remarkable career in both the public and private sectors, and his outstanding  
47 contributions to the nation's financial policy as well as congratulate him on his appointment  
48 as United States Treasurer in the Trump Administration.
