ADOPTED SENATE

A RESOLUTION

- 1 Creating the Senate Study Committee on Franchise Fees; and for other purposes.
- 2 WHEREAS, the substantial growth of large load electricity customers is impacting many
3 unincorporated areas of this state; and
- 4 WHEREAS, municipalities lease their rights of way under franchise agreements to electric
5 utility providers and receive significant compensation in return, including from within many
6 unincorporated areas of this state; and
- 7 WHEREAS, the right for an electric utility provider to utilize county rights of way to reach
8 its customers has economic value that is not currently being recognized for the benefit of the
9 county and its unincorporated area residents; and
- 10 WHEREAS, for decades, residents of unincorporated areas have paid municipal franchise
11 fees to cities in which they do not reside through a charge included in the base rate of their
12 electricity bills; and

13 WHEREAS, the unprecedented growth of large load electricity customers necessitates a
14 reconsideration of the assessment and allocation of municipal franchise fees for electric
15 services within unincorporated areas of this state; and

16 WHEREAS, this state has a compelling government interest to ensure that large load
17 electricity customers, which are particularly situated, are assessed franchise fees or tariffs as
18 a condition of conducting their operations in the unincorporated areas of the county.

19 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE:

20 (1) **Creation of Senate study committee.** There is created the Senate Study Committee
21 on Franchise Fees.

22 (2) **Members and officers.** The committee shall be composed of five members of the
23 Senate to be appointed by the President of the Senate. The President of the Senate shall
24 designate a member of the committee as chairperson of the committee.

25 (3) **Powers and duties.** The committee shall undertake a study of the conditions, needs,
26 issues, and problems mentioned above or related thereto and recommend any action or
27 legislation which the committee deems necessary or appropriate.

28 (4) **Meetings.** The chairperson shall call all meetings of the committee. The committee
29 may conduct such meetings at such places and at such times as it may deem necessary or
30 convenient to enable it to exercise fully and effectively its powers, perform its duties, and
31 accomplish the objectives and purposes of this resolution.

32 (5) **Allowances and funding.**

33 (A) The legislative members of the committee shall receive the allowances provided
34 for in Code Section 28-1-8 of the Official Code of Georgia Annotated.

35 (B) The allowances authorized by this resolution shall not be received by any member
36 of the committee for more than five days unless additional days are authorized. Funds

37 necessary to carry out the provisions of this resolution shall come from funds
38 appropriated to the Senate.

39 **(6) Report.**

40 (A) In the event the committee adopts any specific findings or recommendations that
41 include suggestions for proposed legislation, the chairperson shall file a report of the
42 same prior to the date of abolishment specified in this resolution, subject to
43 subparagraph (C) of this paragraph.

44 (B) In the event the committee adopts a report that does not include suggestions for
45 proposed legislation, the chairperson shall file the report, subject to subparagraph (C)
46 of this paragraph.

47 (C) No report shall be filed unless the same has been approved prior to the date of
48 abolishment specified in this resolution by majority vote of a quorum of the committee.
49 A report so approved shall be signed by the chairperson of the committee and filed with
50 the Secretary of the Senate.

51 (D) In the absence of an approved report, the chairperson may file with the Secretary
52 of the Senate a copy of the minutes of the meetings of the committee in lieu thereof.

53 **(7) Abolishment.** The committee shall stand abolished on December 1, 2025.
