

House Bill 982

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act providing a new charter for the City of Barnesville, approved
2 March 11, 1987 (Ga. L. 1987, p. 3865), as amended, particularly by an Act approved
3 April 12, 2005 (Ga. L. 2005, p. 3510), so as to change the description of the election districts
4 for the city council; to provide for definitions and inclusions; to provide for continuation in
5 office of current members; to provide for related matters; to repeal conflicting laws; and for
6 other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act providing a new charter for the City of Barnesville, approved March 11, 1987 (Ga.
10 L. 1987, p. 3865), as amended, particularly by an Act approved April 12, 2005 (Ga. L. 2005,
11 p. 3510), is amended by revising Section 2.10 as follows:

12 "SECTION 2.10.

13 (a) The legislative authority of the government of this city, except as otherwise specifically
14 provided in this charter, shall be vested in a city council to be composed of a mayor and

15 five councilmembers. The mayor and councilmembers shall be elected in the manner
16 provided by this charter.

17 (b) For the purpose of electing members of the city council, the City of Barnesville is
18 divided into five districts. Such districts shall be and correspond to those five numbered
19 districts described in and set forth in Appendix B attached hereto and further identified as
20 'User: Barnesville Plan Name: barnesville-p1-2025 Plan Type: Local'.

21 (c) For the purposes of such plan:

22 (1) The term 'VTD' shall mean and describe the same geographical boundaries as
23 provided in the report of the Bureau of the Census for the United States decennial census
24 of 2020 for the State of Georgia. The separate numeric designations in a district
25 description which are underneath a VTD heading shall mean and describe individual
26 Blocks within a VTD as provided in the report of the Bureau of the Census for the United
27 States decennial census of 2020 for the State of Georgia; and

28 (2) Except as otherwise provided in the description of any district, whenever the
29 description of any district refers to a named city, it shall mean the geographical
30 boundaries of that city as shown on the census maps for the United States decennial
31 census of 2020 for the State of Georgia.

32 (d) Any part of the City of Barnesville which is not included in any district described in
33 subsection (b) of this section shall be included within that district contiguous to such part
34 which contains the least population according to the United States decennial census of 2020
35 for the State of Georgia.

36 (e) Any part of the City of Barnesville which is described in subsection (b) of this section
37 as being included in a particular district shall nevertheless not be included within such
38 district if such part is not contiguous to such district. Such noncontiguous part shall instead
39 be included within that district contiguous to such part which contains the least population
40 according to the United States decennial census of 2020 for the State of Georgia.

41 (f) Those members of the city council who are serving as such on the effective date of this
 42 Act and any person selected to fill a vacancy in any such office shall continue to serve as
 43 such members until the regular expiration of their respective terms of office and upon the
 44 election and qualification of their respective successors.

45 (g) Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective date of this
 46 Act, shall continue to be designated as Districts 1, 2, 3, 4, and 5, respectively, but as newly
 47 described under this Act, and on and after the effective date of this Act, such members of
 48 the council serving from those former districts shall be deemed to be serving from and
 49 representing their respective districts as newly described under this Act."

50 **SECTION 2.**

51 Said Act is further amended by striking Appendix B and inserting in lieu thereof the
 52 following:
