

The Senate Committee on Regulated Industries and Utilities offered the following substitute to HB 571:

A BILL TO BE ENTITLED  
AN ACT

1 To amend Chapter 34 of Title 43 of the Official Code of Georgia Annotated, relating to  
2 physicians, assistants, and others, so as to provide for the licensing of radiologist assistants;  
3 to provide for continuing education requirements; to repeal a provision relating to radiologist  
4 assistant defined; to provide a short title; to provide for definitions; to provide for licensure  
5 requirements; to provide for renewal requirements; to prohibit holding oneself out as a  
6 radiologist assistant without licensure; to provide for licensure for currently employed  
7 radiologist assistants; to provide for the duties and powers of the Georgia Composite Medical  
8 Board with respect to radiologist assistants; to provide that radiologists may use the services  
9 of licensed radiologist assistants; to prohibit certain practices by radiologist assistants; to  
10 provide for an advisory committee; to provide for statutory construction; to provide for  
11 related matters; to provide for an effective date; to repeal conflicting laws; and for other  
12 purposes.

13 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

**SECTION 1.**

15 Chapter 34 of Title 43 of the Official Code of Georgia Annotated, relating to physicians,  
16 assistants, and others, is amended by revising subsection (a) of Code Section 43-34-11,  
17 relating to continuing education requirement and required training for physicians, as follows:

18 "(a)(1) The board shall be authorized to require persons seeking renewal of a license,  
19 certificate, or permit under this chapter to complete board approved continuing education  
20 of not less than 40 hours biennially. The board shall be authorized to approve courses  
21 offered by institutions of higher learning, specialty societies, or professional  
22 organizations, including, but not limited to, the American Medical Association, the  
23 National Medical Association, and the American Osteopathic Association, the number  
24 of hours required, and the category in which these hours should be earned. This  
25 paragraph shall not apply to respiratory care professionals, persons seeking renewal of  
26 certification as respiratory care professionals, clinical perfusionists, persons seeking  
27 renewal of licensure as a clinical perfusionist, licensed orthotists or prosthetists, persons  
28 seeking renewal of licensure as an orthotist or prosthetist, genetic counselors, ~~or persons~~  
29 ~~seeking renewal of licensure as a genetic counselor, radiologist assistants, or persons~~  
30 seeking renewal of licensure as a radiologist assistant.

31 (2) The board shall be authorized to require persons seeking renewal of certification as  
32 respiratory care professionals under Article 6 of this chapter to complete board approved  
33 continuing education. The board shall be authorized to establish the number of hours of  
34 continuing education required biennially for renewal of certification as a respiratory care  
35 professional and the categories in which these hours should be earned. The board shall  
36 be authorized to approve courses offered by institutions of higher learning, specialty  
37 societies, or professional organizations. Any action taken by the board pursuant to this  
38 paragraph shall be taken in conformity with the provisions of Code Section 43-34-143.

39 (3) The board shall be authorized to require persons seeking renewal of licensure as  
40 clinical perfusionists under Article 7 of this chapter to complete board approved

41 continuing education. The board shall be authorized to establish the number of hours of  
42 continuing education required biennially for renewal of licensure as a clinical perfusionist  
43 and the categories in which these hours should be earned. The board shall be authorized  
44 to approve courses offered by institutions of higher learning, specialty societies, or  
45 professional organizations. Any action taken by the board pursuant to this paragraph  
46 shall be taken in conformity with the provisions of Code Section 43-34-172.

47 (4) The board shall be authorized to require persons seeking renewal of licensure to  
48 practice orthotics or prosthetics under Article 8 of this chapter to complete board  
49 approved continuing education. The board shall be authorized to establish the number  
50 of hours of continuing education required biennially for renewal of licensure to practice  
51 orthotics or prosthetics and the categories in which these hours should be earned,  
52 provided that the maximum number of hours of continuing education required for  
53 renewal of licensure shall not exceed 40 hours. The board shall be authorized to approve  
54 courses offered by institutions of higher learning, specialty societies, or professional  
55 organizations. Any action taken by the board pursuant to this paragraph shall be taken  
56 in conformity with the provisions of subsection (a) of Code Section 43-34-200.

57 (5) The board shall be authorized to require persons seeking renewal of licensure to  
58 practice genetic counseling under Article 12 of this chapter to complete board approved  
59 continuing education. The board shall be authorized to establish the number of hours of  
60 continuing education required biennially for renewal of licensure to practice genetic  
61 counseling and the categories in which these hours should be earned, provided that the  
62 number of hours of continuing education required for renewal of licensure shall not be  
63 less than 30 hours biennially. The board shall be authorized to approve courses offered  
64 by institutions of higher learning, specialty societies, or professional organizations. Any  
65 action taken by the board pursuant to this paragraph shall be taken in conformity with the  
66 provisions of subsection (b) of Code Section 43-34-313.

67 (6) The board shall be authorized to require persons seeking renewal of licensure to  
68 practice as a radiologist assistant under Article 13 of this chapter to complete board  
69 approved continuing education. The board shall be authorized to establish the number  
70 of hours of continuing education required biennially for renewal of licensure to practice  
71 as a radiologist assistant and the categories in which these hours should be earned. The  
72 board shall be authorized to approve courses offered by institutions of higher learning,  
73 specialty societies, or professional organizations. Any action taken by the board pursuant  
74 to this paragraph shall be taken in conformity with the provisions of subsection (b) of  
75 Code Section 43-34-334.

76 ~~(6)~~(7) On and after January 1, 2022, all physicians shall be required to receive one-time  
77 education and training, for a minimum of two hours, regarding professional boundaries  
78 and physician sexual misconduct. Such education and training shall include subject  
79 matter relating to how to proceed with basic as well as sensitive or intimate examinations  
80 and the communication with patients that is required as a component of such  
81 examinations. Such education and training shall be established by the board and shall be  
82 informed by members of the public, as best possible."

83 **SECTION 2.**

84 Said chapter is further amended by repealing Code Section 43-34-12, relating to radiologist  
85 assistant defined.

86 **SECTION 3.**

87 Said chapter is further amended by adding a new article to read as follows:

"ARTICLE 1389 43-34-330.90 This article shall be known and may be cited as the 'Radiologist Assistant Act.'91 43-34-331.92 As used in this article, the term:93 (1) 'Board' means the Georgia Composite Medical Board.94 (2) 'Radiologist' means a physician who is licensed to practice medicine pursuant to  
95 Article 2 of this chapter and who is certified by the American Board of Radiology, the  
96 American Osteopathic Board of Radiology, or the Royal College of Physicians and  
97 Surgeons of Canada.98 (3) 'Radiologist assistant' means an advanced level certified diagnostic radiologic  
99 technologist who assists radiologists under the on site direct supervision of a radiologist  
100 as defined by the Georgia Composite Medical Board in performing advanced diagnostic  
101 imaging procedures as determined by board rule, according to levels of supervision as  
102 defined by the Centers for Medicare and Medicaid Services including, but not limited to,  
103 enteral and parenteral procedures when performed under the on site direct supervision of  
104 the radiologist and may include injecting diagnostic agents to sites other than intravenous,  
105 performing diagnostic aspirations and localizations, and assisting radiologists with other  
106 invasive procedures, according to levels of supervision as defined by the Centers for  
107 Medicare and Medicaid Services. Such radiologist assistant may with general  
108 supervision perform other noninvasive procedures unless said procedures are expressly  
109 restricted by the board to not be performed by radiologist assistants under general  
110 supervision. Such radiologist assistant may also perform other procedures under general  
111 supervision as may be authorized by the board.

112 43-34-332.

113 A person shall be qualified for licensure as a radiologist assistant and the board shall issue  
114 a license if that person:

115 (1) Has applied in writing in form and substance satisfactory to the board and is at least  
116 21 years of age;

117 (2) Has not engaged in conduct or activities which would constitute grounds for  
118 discipline under this article;

119 (3) Is registered and credentialed as a radiographer with the American Registry of  
120 Radiologic Technologists;

121 (4) Is certified and registered:

122 (A) As a radiologist assistant with the American Registry of Radiologic Technologists;  
123 or

124 (B) As a radiology practitioner assistant with the Certification Board for Radiology  
125 Practitioner Assistants and the American Registry of Radiologic Technologists;

126 (5) Has paid the fees required by rule; and

127 (6) Has met any other requirements established by rule.

128 43-34-333.

129 (a) Licenses issued by the board pursuant to this article shall be subject to renewal and  
130 shall be valid for up to two years unless otherwise specified by this article and shall be  
131 renewable biennially on the renewal date established by the board.

132 (b) The board shall be authorized to, in conformance with paragraph (6) of subsection (a)  
133 of Code Section 43-34-11:

134 (1) Require persons seeking renewal of licensure under this article to complete board  
135 approved continuing education;

136 (2) Establish the number of hours of continuing education to be completed as well as the  
137 categories in which the continuing education is to be completed; and

138 (3) Maintain continued certification and registration as a radiologist assistant with the  
139 American Registry of Radiologic technologist or radiology practitioner assistant with the  
140 Certification Board for Radiology Practitioner Assistants and the American Registry of  
141 Radiologic Technologists.

142 (c) A person who has permitted his or her license to expire or who has had his or her  
143 license on inactive status may have his or her license restored by:

144 (1) Making application to the board;

145 (2) Filing proof acceptable to the board of his or her fitness to have his or her license  
146 restored, including, but not limited to, sworn evidence certifying to active practice in  
147 another jurisdiction satisfactory to the board; and

148 (3) Paying the required restoration fee.

149 If the person has not maintained an active practice in another jurisdiction satisfactory to the  
150 board, the board shall determine, by an evaluation program established by rule, such  
151 person's fitness to resume active status and may require such person to complete a period  
152 of evaluated clinical experience and successful completion of an examination.

153 (d) A person who notifies the board on forms prescribed thereby may elect to place his or  
154 her license on an inactive status and shall, subject to rules of the board, be excused from  
155 payment of renewal fees until he or she notifies the board of his or her desire to resume  
156 active status. A person requesting restoration from inactive status shall be required to pay  
157 the current renewal fee and shall be required to restore his or her license as provided in  
158 subsection (c) of this Code section. A radiologist assistant whose license is on inactive  
159 status shall not engage in the scope of practice for radiologist assistants in this state.

160 (e) A person whose license expired while he or she was:

161 (1) In federal service on active duty within the armed forces of the United States or with  
162 the state militia and called into service or training; or

163 (2) In training or education under the supervision of the United States preliminary to  
164 induction into military service

165 may have his or her license renewed or restored without paying a lapsed renewal fee if,  
166 within two years after termination from the service, training, or education except under  
167 conditions other than honorable, he or she furnishes the board with satisfactory evidence  
168 that he or she has been so engaged and that his or her service, training, or education has  
169 been terminated.

170 43-34-334.

171 (a) On and after July 1, 2026, a person shall not engage in the scope of practice for  
172 radiologist assistants in this state without a valid license issued by the board pursuant to  
173 this article.

174 (b) A person shall not hold himself or herself out as a radiologist assistant unless he or she  
175 holds a license issued by the board in accordance with this article. A person not licensed  
176 by the board pursuant to this article shall not use in connection with his or her name or  
177 place of business the terms 'radiologist assistant' or any words, letters, abbreviations, or  
178 insignia indicating or implying that the person holds a license as a radiologist assistant.

179 (c) A person who verifies to the board that he or she is employed in this state as a  
180 radiologist assistant as of the effective date of this article shall by operation of law be  
181 authorized to practice as a radiologist assistant in this state on or after July 1, 2026,  
182 contingent upon such individual having applied with the board for appropriate licensure.

184 (a) A radiologist may use the services of a radiologist assistant under the on site direct  
185 supervision of such radiologist, provided that such radiologist assistant is duly qualified  
186 and licensed pursuant to this article.

187 (b) Notwithstanding subsection (a) of this Code section, a radiologist assistant may with  
188 general supervision perform other noninvasive procedures unless said procedures are  
189 expressly restricted by the board to not be performed by radiologist assistants under general

190 supervision. Such radiologist assistant may also perform other procedures under general  
191 supervision as may be authorized by the board.

192 (c) A radiologist assistant shall not interpret images, make diagnoses, or prescribe  
193 medications or therapies.

194 (d) Any rules and regulations adopted by the board pertaining to the scope of practice as  
195 a radiologist assistant in this state shall be consistent with guidelines adopted by the  
196 American College of Radiology, the American Society of Radiologic Technologists, the  
197 American Registry of Radiologic Technologists, or any other entity deemed appropriate  
198 by the board.

199 43-34-336.

200 The board shall have the power and responsibility to:

201 (1) Determine the qualifications and fitness of applicants for licensure and renewal of  
202 licensure;

203 (2) Adopt and revise rules consistent with the laws of the State of Georgia that are  
204 necessary to conduct its business, carry out its duties, and administer this article;

205 (3) Examine for, approve, issue, deny, revoke, suspend, sanction, and renew the licenses  
206 of applicants and radiologist assistants under this article and conduct hearings in  
207 connection with these actions;

208 (4) Conduct hearings on complaints concerning violations of this article and the rules  
209 adopted under this article and cause the prosecution and enjoinder of the violations;

210 (5) Establish application, examination, and certification fees;

211 (6) Establish continuing education requirements; and

212 (7) Establish the number of radiologist assistants that may be supervised by a radiologist  
213 according to levels of supervision as defined by the Centers for Medicare and Medicaid  
214 Services.

215 43-34-337.

216 The board shall appoint an advisory committee. The advisory committee shall consist of  
217 no fewer than five individuals and shall include at least one licensed physician who  
218 practices radiology, three licensed radiologist assistants, and one consumer representative.  
219 Members shall receive no compensation for service on the committee. The committee shall  
220 have such advisory duties and responsibilities as the board may determine, including, but  
221 not limited to, consulting with the board on the issuance, denial, suspension, and revocation  
222 of licenses and the promulgation of rules and regulations under this article. The initial  
223 members of the advisory committee may include persons eligible for licensing under this  
224 article. Subsequent advisory committee members must be licensed pursuant to this article.

225 43-34-338.

226 Nothing in this article shall be construed to prohibit:

227 (1) The performance of any tasks or responsibilities by any student engaged in clinical  
228 training in a general hospital, provided such practice is limited to clinical training that  
229 shall be carried out under the direct supervision of a radiologist;

230 (2) The performance of any tasks or responsibilities by any person licensed under this  
231 title, provided such tasks or responsibilities are permitted by the article governing the  
232 profession pursuant to which such person is licensed; or

233 (3) The performance of any tasks or responsibilities by any legally qualified radiologist  
234 assistants of any other state or territory who is serving in the armed forces or the Public  
235 Health Service of the United States or who is employed by the United States Department  
236 of Veterans Affairs, while engaged in the performance of his or her duties."

#### **SECTION 4.**

238 This Act shall become effective upon its approval by the Governor or upon its becoming law  
239 without such approval.

**SECTION 5.**

241 All laws and parts of laws in conflict with this Act are repealed.
