

The House Committee on Public and Community Health offers the following substitute to SB 162:

A BILL TO BE ENTITLED  
AN ACT

1 To amend Article 1 of Chapter 34 of Title 43 of the Official Code of Georgia Annotated,  
2 relating to Georgia Composite Medical Board, so as to provide for the board to implement  
3 an automated licensing system for certain healthcare providers in this state; to provide for  
4 guidelines; to provide for a short title; to provide for legislative declarations and intent; to  
5 provide for contingent effectiveness and automatic repeal; to provide for related matters; to  
6 repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 This Act shall be known and may be cited as "The Paul Brock Act."

10 **SECTION 2.**

11 The Georgia Composite Medical Board has recently implemented a new data management  
12 system used in the licensing of healthcare providers. It is the intent of the General Assembly  
13 that this new system be further modified to allow healthcare providers to input credentialing  
14 information specific to their facility with the outcome being that, once credentialed and

15 licensed in Georgia, the healthcare provider would be available to all healthcare facilities  
16 without the need for additional credentialing.

17 **SECTION 3.**

18 Article 1 of Chapter 34 of Title 43 of the Official Code of Georgia Annotated, relating to  
19 Georgia Composite Medical Board, is amended in Code Section 43-34-6, relating to board  
20 as an independent agency, executive director, meetings and hearings, licenses, certificates,  
21 and permits, investigations, venue, credit to veterans, and annual report, by adding new  
22 subsections to read as follows:

23 "(k) No later than January 1, 2027, the board shall modify its data management software  
24 system to streamline and automate the licensing process for physicians, physician  
25 assistants, and anesthesiologist assistants. No later than January 1, 2027, such system shall  
26 be fully operational for other healthcare providers licensed by the board.

27 (l) The system provided for in subsection (k) of this Code section may:

28 (1) Organize, verify, and store the licenses of healthcare providers, allowing for a single  
29 verification process that results in authorization state wide, provided that a healthcare  
30 facility, licensee, or applicant inputs the credentialing information and agrees to such  
31 authorization;

32 (2) If available, be customizable so that a healthcare facility can add requirements to  
33 meet such facility's rules, regulations, or bylaws;

34 (3) Allow any healthcare facility to accept the information for licensing as acceptance  
35 for credentialing and any healthcare provider to add additional requirements for  
36 credentialing in their facility;

37 (4) Allow for administrative approval of licenses by the board to provide for physicians,  
38 physician assistants, and anesthesiologist assistants to be available for employment  
39 immediately upon meeting all requirements; and

40 (5) Perform any other functions the board deems necessary to improve licensing  
41 processes under this chapter."

42 **SECTION 4.**

43 This Act shall become effective only if funds are specifically appropriated for the purposes  
44 of such Act in an appropriations Act enacted by the General Assembly and shall stand  
45 repealed by operation of law on December 31, 2030, if no such funding becomes available  
46 before such date.

47 **SECTION 5.**

48 All laws and parts of laws in conflict with this Act are repealed.
