A RESOLUTION

1 Recognizing and commending Andrew Adams, founder and owner of ProLevel Recovery;
2 and for other purposes.

3 WHEREAS, Andrew Adams is the founder and owner of ProLevel Recovery, a
4 Georgia-based multidisciplinary sports medicine and recovery organization providing
5 comprehensive physical therapy, chiropractic care, and advanced recovery services to
6 individuals across the state; and
