

House Bill 1329

A BILL TO BE ENTITLED
AN ACT

1 To amend Chapter 13 of Title 16 of the Official Code of Georgia Annotated, relating to
2 controlled substances, so as to provide for certain provisions relating to Schedule I controlled
3 substances; to provide for certain provisions relating to the definition of dangerous drugs; to
4 provide for related matters; to provide for an effective date; to repeal conflicting laws; and
5 for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 Chapter 13 of Title 16 of the Official Code of Georgia Annotated, relating to controlled
9 substances, is amended in Code Section 16-13-25, relating to Schedule I controlled
10 substances, by revising subparagraph (E) of paragraph (16) as follows:

11 "(E) By substitution at the 5-position or 6-position with a nitro, alkyl, halide, cyano,
12 or acetyl group or primary amine;"

13 **SECTION 2.**

14 Said chapter is further amended in Code Section 16-13-71, relating to dangerous drug, by
15 adding new paragraphs to subsection (b) to read as follows:

66 **SECTION 3.**

67 Said chapter is further amended in subsection (b) of said Code section by repealing and
 68 reserving paragraph (324) and by revising paragraphs (60.3), (160.5), and (217.2) as follows:

69 "(60.3) Antihemophilic factor (recombinant), ~~Fe-VWF-XTEN fusion protein-ehrl;~~"
 70 "(160.5) Chikungunya vaccine, ~~Live;~~"
 71 "(217.2) COVID-19 Vaccine, ~~mRNA;~~"

72 **SECTION 4.**

73 Said chapter is further amended in subsection (c) of said Code section by revising paragraph
 74 (9.33) as follows:

75 "(9.33) Epinephrine ==:

76 (A) When ~~when~~ used in a device that delivers a metered spray of 0.125 mg. of
 77 epinephrine or less to provide temporary relief for symptoms of mild, intermittent asthma
 78 and is a product in finished dosage formulation in its original container that has been
 79 approved by and labeled in compliance with the U.S. Food and Drug Administration
 80 (FDA); and

81 (B) When distributed by a pharmacist as provided by the State Board of Pharmacy, in a
 82 device that delivers a spray of 2 mg. of epinephrine or less to provide emergency
 83 treatment of allergic reactions, including anaphylaxis, and is a product in finished dosage
 84 formulation in its original container that has been approved by and labeled in compliance
 85 with the U.S. Food and Drug Administration (FDA);"

86 **SECTION 5.**

87 This Act shall become effective upon its approval by the Governor or upon its becoming law
 88 without such approval.

89 **SECTION 6.**

90 All laws and parts of laws in conflict with this Act are repealed.
