

Senate Bill 587

A BILL TO BE ENTITLED
AN ACT

1 To amend Article 1 of Chapter 12 of Title 16 of the Official Code of Georgia Annotated,
2 relating to general provisions regarding offenses against public health and morals, so as to
3 provide for the establishment of an animal cruelty database; to provide for purpose and
4 funding; to require the Prosecuting Attorneys' Council of the State of Georgia to create,
5 administer, and maintain such database; to provide for minimum requirements; to provide
6 for reporting and forms; to provide for related matters; to repeal conflicting laws; and for
7 other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.**

10 Article 1 of Chapter 12 of Title 16 of the Official Code of Georgia Annotated, relating to
11 general provisions regarding offenses against public health and morals, is amended in Code
12 Section 16-12-4, relating to cruelty to animals, by adding a new subsection to read as
13 follows:

14 "(i)(1) Subject to appropriations by the General Assembly or other available funding, by
15 January 1, 2027, the Prosecuting Attorneys' Council of the State of Georgia shall create,
16 administer, and maintain on its website a state-wide, publicly searchable animal cruelty

17 database. The primary purpose of such database shall be to assist animal shelters, animal
18 protection and control agencies, and other organizations and members of the public
19 involved in animal placement determinations in screening prospective owners and
20 preventing animals from being placed in dangerous situations. At minimum, such
21 database shall:

22 (A) List the full names of each individual who has been convicted of or entered a plea
23 of guilty or nolo contendere to any violation of this Code section; Code Sections
24 16-6-6, 16-7-21.2, 16-12-37; or subsections (c) or (d) of Code Section 16-11-107;

25 (B) Be accessible at no cost; and

26 (C) Be updated no less than monthly.

27 (2) The Prosecuting Attorneys' Council of the State of Georgia shall be authorized to
28 solicit input from state law enforcement and prosecuting attorneys in determining
29 information to be included in the animal cruelty database. All state law enforcement,
30 prosecution and corrections agencies, offices, and departments shall cooperate with and
31 shall provide in a timely manner any information acquired relating to a violation
32 described in subparagraph (1)(A) of this subsection to the Prosecuting Attorneys' Council
33 of the State of Georgia to be included in the animal cruelty database in a format
34 prescribed by such council pursuant to paragraph (3) of this subsection.

35 (3) The Prosecuting Attorneys' Council of the State of Georgia shall be authorized to
36 create and promulgate a uniform reporting form to be used by state law enforcement,
37 prosecution and corrections agencies, offices, and departments in reporting information
38 for inclusion in the animal cruelty database."

39 **SECTION 2.**

40 All laws and parts of laws in conflict with this Act are repealed.
