**AS PASSED SENATE**

A BILL TO BE ENTITLED  
AN ACT

1 To amend Subpart 2A of Part 1 of Article 16 of Chapter 2 of Title 20 of the Official Code  
2 of Georgia Annotated, relating to clubs and organizations, so as to provide for equal access  
3 to public schools for students engaging in political or philosophical expression; to authorize  
4 the organization of partisan and nonpartisan student groups and gatherings; to provide for  
5 school disclaimers of sponsorship; to prohibit discrimination based on the content of student  
6 speech within a limited open forum; to provide for the maintenance of order and discipline;  
7 to provide for a short title; to provide for definitions; to provide for related matters; to  
8 provide for an effective date; to repeal conflicting laws; and for other purposes.

9 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

10 **SECTION 1.**

11 This Act shall be known and may be cited as the "True Patriotism and Universal Student  
12 Access (TPUSA) Act."

Subpart 2A of Part 1 of Article 16 of Chapter 2 of Title 20 of the Official Code of Georgia Annotated, relating to clubs and organizations, is amended by adding a new Code section to read as follows:

"20-2-706.

(a) As used in this Code section, the term:

(1) 'Meeting' means and includes those activities of student groups which are permitted under a public school's limited open forum and are not directly related to the school curriculum.

(2) 'Noninstructional time' means time set aside by a public school before actual classroom instruction begins or after actual classroom instruction ends.

(3) 'Sponsor' means an individual who is in whole or in part responsible for the sponsorship of a meeting. Such term shall not include a school administrator, teacher, or other school personnel who has been assigned to attend a meeting for custodial purposes.

(4) 'Sponsorship' means the act of promoting, leading, or participating in a meeting.

(b)(1) Students enrolled in public schools in this state shall be permitted to engage in political activities and expression before, during, and after the school day in the same manner and to the same extent that students may engage in nonpolitical activities and expression.

(2) Students enrolled in public schools in this state may organize partisan or nonpartisan political activities and groups before, during, and after school to the same extent that students are permitted to organize other noncurricular student activities and groups during noninstructional time.

(c)(1) It shall be unlawful for any public school which has a limited open forum to deny equal access or a fair opportunity to, or discriminate against, any students enrolled in such public school who wish to conduct a meeting within such limited open forum on the basis

42 (2) A public school shall be deemed to have a limited open forum whenever such school  
43 grants an offering to or opportunity for one or more noncurricular related student groups  
44 to meet on school premises during noninstructional time.

45 (3) Public schools shall be deemed to offer a fair opportunity to students enrolled in such  
46 school who wish to conduct a meeting within its limited open forum if such school  
47 uniformly provides that:

48 (A) The meeting is voluntary and student initiated;

49 (B) There is no sponsorship of the meeting by the school or any governmental entity  
50 or its employees or agents acting in an official capacity;

51 (C) The meeting does not materially and substantially interfere with the orderly  
52 conduct of educational activities and discipline within the school;

53 (D) The meeting does not infringe on the rights of other students; and

54 (E) Individuals not affiliated with the school may not direct, conduct, control, or  
55 regularly attend activities of student groups.

56 (d)(1) Partisan and nonpartisan political groups shall be given the same access to public  
57 school facilities for assembling as is given to other noncurricular groups without  
58 discrimination based on the political content of the expression of such groups.

59 (2) Partisan and nonpartisan political groups shall be given the same opportunity to  
60 advertise or announce meetings and activities as is given to other noncurricular groups  
61 without discrimination based on the political content of the students' expression.

62 (e) A public school shall only disclaim school sponsorship of noncurricular student groups  
63 and related events in a manner that neither favors nor disfavors student groups that meet  
64 to engage in political activity or political speech.

65 (f) Students enrolled in public schools shall be permitted to wear clothing, accessories, and  
66 jewelry that display political messages or political symbols in the same manner and to the

67 same extent that other types of clothing, accessories, and jewelry that display messages or  
68 symbols are permitted under the school dress code.

69 (g) Nothing in this Code section shall be construed to authorize the state or any political  
70 subdivision thereof to:

71 (1) Influence the form or content of any political, philosophical, or ideological activity;

72 (2) Require any person to participate in politics or political activity;

73 (3) Expend public funds beyond the incidental cost of providing the space for student  
74 initiated meetings;

75 (4) Compel any public school employee or agent to attend a meeting if the content of the  
76 speech at the meeting is contrary to the beliefs of the employee or agent;

77 (5) Sanction meetings that are otherwise unlawful; or

78 (6) Abridge the constitutional rights of any individual.

79 (h) Nothing in this Code section shall be construed to limit the authority of a public school  
80 or its employees or agents to maintain order and discipline on school premises, to protect  
81 the well-being of students and staff, and to assure that attendance of students at meetings  
82 is voluntary."

83 **SECTION 3.**

84 This Act shall become effective on July 1, 2026.

85 **SECTION 4.**

86 All laws and parts of laws in conflict with this Act are repealed.
