AS PASSED SENATE

A BILL TO BE ENTITLED

AN ACT

1 To amend Chapter 5 of Title 40 of the Official Code of Georgia Annotated, relating to
 2 drivers' licenses, so as to provide for revocation and expiration of commercial drivers'
 3 licenses for noncitizens; to provide for testing requirements for the transfer of commercial
 4 drivers' licenses for noncitizens; to amend Chapter 36 of Title 50 of the Official Code of
 5 Georgia Annotated, relating to verification of lawful presence within the United States, so
 6 as to make conforming changes; to provide for related matters; to repeal conflicting laws; and
 7 for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.**

10 Chapter 5 of Title 40 of the Official Code of Georgia Annotated, relating to drivers' licenses,
 11 is amended by revising subsection (a) of Code Section 40-5-21.1, relating to temporary
 12 licenses, permits, or special identification cards, foreign licenses or identification cards as
 13 evidence of legal presence in the United States, and extensions, as follows:

14 "(a)(1) Notwithstanding any other provision of this title, an applicant who presents in
 15 person valid documentary evidence of:

16 ~~(1)~~(A) Admission to the United States in a valid, unexpired nonimmigrant status;

- 17 ~~(2)(B)~~ A pending or approved application for asylum in the United States;
- 18 ~~(3)(C)~~ Admission into the United States in refugee status;
- 19 ~~(4)(D)~~ An approved application for temporary protected status in the United States;
- 20 ~~(5)(E)~~ Approved deferred action status;
- 21 ~~(6)(F)~~ Other federal documentation verified by the United States Department of
22 Homeland Security to be valid documentary evidence of lawful presence in the United
23 States under federal immigration law; or
- 24 ~~(7)(G)~~ Verification of lawful presence as provided by Code Section 40-5-21.2 may be
25 issued a temporary license, permit, or special identification card. Except as provided
26 in paragraph (2) of this subsection, such ~~Such~~ temporary license, permit, or special
27 identification card shall be valid only during the period of time of the applicant's
28 authorized stay in the United States or five years, whichever occurs first.
- 29 (2) If a noncitizen has been issued a commercial driver's license under Article 7 of this
30 chapter, the 'Uniform Commercial Driver's License Act,' such license shall be
31 automatically revoked upon the expiration of such person's visa or five years, whichever
32 occurs first."

33 **SECTION 2.**

34 Said chapter is further amended by revising paragraph (1) of subsection (a) of Code
35 Section 40-5-32, relating to expiration and renewal of licenses, reexamination required, and
36 electronic renewal notices, as follows:

37 "(a)(1) Except as otherwise provided in this Code section, every driver's license shall
38 expire on the licensee's birthday in the eighth year following the issuance of such license.
39 Notwithstanding the foregoing;

40 (A) Any ~~any~~ commercial driver's license that contains an H or X endorsement as
41 defined in subsection (c) of Code Section 40-5-150 shall expire on the date of

42 expiration of the licensee's security threat assessment conducted by the Transportation
43 Security Administration of the United States Department of Homeland Security; and
44 (B) Any commercial driver's license issued to a noncitizen shall expire in accordance
45 with Code Section 40-5-21.1."

46 **SECTION 3.**

47 Said chapter is further amended by revising subsection (h) of and adding a new subsection
48 to Code Section 40-5-150, relating to contents of license, classifications, endorsements and
49 restrictions, information to be obtained before issuance, notice of issuance, expiration of
50 license, and renewal, as follows:

51 "(h) When applying for renewal of a commercial driver's license, the applicant shall
52 complete the application form required by subsection (a) of Code Section 40-5-149,
53 providing updated information and required medical certifications. If the applicant wishes
54 to retain a hazardous materials endorsement, the written test for a hazardous materials
55 endorsement ~~must~~ shall be taken and passed."

56 "(j) Before transferring a commercial driver's license from another state to this state, an
57 applicant who is a noncitizen shall take and pass the knowledge and skills test for driving
58 a commercial vehicle under Code Section 40-5-147."

59 **SECTION 4.**

60 Chapter 36 of Title 50 of the Official Code of Georgia Annotated, relating to verification of
61 lawful presence within the United States, is amended by revising paragraph (8) of
62 subsection (f) of Code Section 50-36-2, relating to secure and verifiable identity document
63 and applicability, as follows:

64 "(8) Paragraph (2) of subsection (a) of Code Section 40-5-21 or ~~paragraph (2) of~~
65 ~~subsection (a)~~ subparagraph (a)(1)(B) of Code Section 40-5-21.1;"
