

House Bill 1550

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act providing a new charter for the City of Byron, approved February 13, 1941
2 (Ga. L. 1941, p. 1210), as amended, particularly by an Act approved April 13, 2001 (Ga. L.
3 2001, p. 3770), so as to change the corporate limits of the City of Byron; to provide for
4 related matters; to provide a contingent effective date; to provide for automatic repeal; to
5 repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 An Act providing a new charter for the City of Byron, approved February 13, 1941 (Ga. L.
9 1941, p. 1210), as amended, particularly by an Act approved April 13, 2001 (Ga. L. 2001,
10 p. 3770), is amended by revising Section 2.1 by adding a new paragraph to read as follows:

11 "(6) Beginning at and including the western right of way of Housers Mill Road at its
12 intersection with the southern land line of Land Lot 15 of the 5th Land District and
13 proceeding in a northerly direction along the western right of way of Housers Mill Road
14 approximately 5,220 feet, more or less, to its intersection with the southwestern right of
15 way line of the Georgia Highway 247 connector; then proceed easterly along the southern
16 right or way line of the Georgia Highway 247 connector to the eastern most right of way

17 line of Housers Mill Road to a point; then proceed in a southerly direction along the
18 eastern most right of way line of Housers Mill Road to its intersection with the southern
19 land line of Land Lot 15 of the 5th Land District; thereafter, proceed due west along the
20 southern line of Land Lot 15 of the 5th Land District to the point of beginning.”

21 **SECTION 2.**

22 This Act shall become effective on June 1, 2026, provided that an Act to amend an Act
23 providing a new charter for the City of Fort Valley, approved August 22, 1907 (Ga. L. 1907,
24 p. 651), as amended, so as to deannex the right of way is enacted in the 2026 regular session
25 of the General Assembly and approved by the Governor or becomes law without such
26 approval; if such deannexation Act is not so enacted and approved, this Act shall not become
27 effective and shall be automatically repealed on June 1, 2026.

28 **SECTION 3.**

29 All laws and parts of laws in conflict with this Act are repealed.
