A RESOLUTION

1 Commending Dr. Terry L. Hudson II; and for other purposes.

2 WHEREAS, Dr. Terry L. Hudson II is a distinguished resident of the State of Georgia whose
3 unwavering commitment to national security and public service has made a profound impact
4 both within and beyond the military community; and

5 WHEREAS, Dr. Hudson honorably served his country in the United States Army as a 35F
6 Intelligence Analyst from 2012 to 2016, demonstrating exceptional dedication,
7 professionalism, and integrity in the defense of the nation; and

8 WHEREAS, following his military service, Dr. Hudson continued to support critical national
9 security missions through both industry and federal service, contributing his expertise to key
10 operations and organizations, including Combined Joint Task Force - Operation Inherent
11 Resolve (CJTF-OIR), United States Army Central (ARCENT), United States Army
12 Intelligence and Security Command (INSCOM), and other vital mission partners; and

13 WHEREAS, Dr. Hudson has further distinguished himself through his work in security roles
14 supporting the Maneuver Center of Excellence, including the Officer Candidate School

15 program and specialized security responsibilities essential to the readiness and safety of
16 military personnel; and

17 WHEREAS, he currently serves with distinction as the sole Garrison Security Manager at
18 Fort Benning, Georgia, where he provides critical security oversight and support to
19 directorates and tenant units, ensuring the safety and protection of civilians, military
20 personnel, and contractors across the installation; and

21 WHEREAS, in addition to his exemplary professional service, Dr. Hudson has demonstrated
22 an extraordinary commitment to academic excellence, earning a Bachelor of Science in
23 Business Administration, a Graduate Certificate in Forensic Psychology, a Master of Science
24 in Forensic Sciences, and a Doctor of Forensic Sciences; and

25 WHEREAS, Dr. Hudson's achievements reflect a steadfast dedication to lifelong learning,
26 leadership, and service, making him a model citizen and an inspiration to all Georgians.

27 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body
28 commend Dr. Terry L. Hudson II for his outstanding service to the State of Georgia and the
29 United States and extend their sincerest appreciation for his continued contributions to
30 national security and public safety.
