A RESOLUTION

1 Commending Dr. Delvecchio S. Finley; and for other purposes.

2 WHEREAS, Dr. Delvecchio S. Finley is an accomplished healthcare executive whose
3 leadership and service have strengthened major health systems and advanced patient-centered
4 care across the United States; and

5 WHEREAS, his exemplary career includes previous service as chief executive officer of
6 Alameda Health System, chief executive officer of LA County/Harbor-UCLA Medical
7 Center, and interim chief operating officer for Laguna Honda Hospital and Rehabilitation
8 Center; and

9 WHEREAS, in 2021, he returned to Georgia to join Atrium Health Navicent following its
10 strategic combination with Atrium Health, bringing extensive expertise to support
11 systemwide integration, operational alignment, and long-term growth; and

12 WHEREAS, as president of Atrium Health Navicent, he now leads one of the largest
13 nonprofit and leading academic health systems in the United States, providing organizational
14 direction, advancing strategic initiatives, and overseeing the adoption of new technologies
15 that position the institution to meet evolving healthcare needs; and

16 WHEREAS, a Fellow of the American College of Healthcare Executives, he currently serves
17 as chairman-elect of the organization and has previously served as a board member of the
18 American Hospital Association as well as chair of the America's Essential Hospitals Institute;

20 WHEREAS, Dr. Delvecchio S. Finley contributes substantially to statewide leadership in
21 Georgia as a board member of the Georgia Hospital Association, the Georgia Chamber of
22 Commerce, the Georgia Alliance of Community Hospitals, Central Georgia Health Network,
23 Secure Health, Vizient Southern States, and the Georgia Research Alliance; and

24 WHEREAS, he has earned national recognition for his accomplishments, including
25 placement on Modern Healthcare's Top 25 Minorities in Healthcare Watch List as well as
26 Modern Healthcare's Up and Comers Award and the American College of Healthcare
27 Executives' Robert S. Hudgens Young Healthcare Executive of the Year Award; and

28 WHEREAS, it is abundantly fitting and proper that this exceptional individual be
29 appropriately honored during this special time.
