A RESOLUTION

1 Dedicating certain portions of the state highway system; and for other purposes.

**PART I**

3 WHEREAS, Officer Drew Haynes Brown was highly regarded by the citizens of his  
4 community and state and by local government officials as a person of unquestioned integrity  
5 and dedication to the sound principles of law enforcement; and

6 WHEREAS, Officer Brown diligently and conscientiously devoted innumerable hours of his  
7 time, talents, and energy toward the betterment of his community and state as evidenced  
8 dramatically by his superlative service as a police officer in Cobb County; and

9 WHEREAS, a native of Thomaston, Georgia, and graduate of Osborne High School in Cobb  
10 County, Officer Brown was the son of Mary Christine Vaughan Brown and Elmore "Buddy"  
11 Haynes Brown, who was a detective with the Cobb County Police Department in the 1970s;  
12 and

13 WHEREAS, after attending Kennesaw College to study business law, Officer Brown began  
14 his service with the Cobb County Police Department on September 2, 1977, and served as

15 a uniform patrol officer at Precinct 2 in Mableton before joining the then newly created  
16 Marietta-Cobb DUI Task Force in 1982; and

17 WHEREAS, his life was tragically cut short in 1983 after his patrol vehicle was struck by  
18 a drunk driver while he was operating radar on Highway 41; and

19 WHEREAS, Officer Brown led an exceptional career of public service and his inspiring  
20 commitment to the welfare of others stands as a shining example of the positive effect law  
21 enforcement professionals have on the lives and well-being of others; and

22 WHEREAS, he exhibited extraordinary devotion to public service, outstanding loyalty, fine  
23 leadership, and meticulous attention to detail in all of his duties and it is abundantly fitting  
24 and proper that this remarkable and distinguished Georgian be recognized appropriately by  
25 dedicating an intersection in his memory.

## PART II

27 WHEREAS, Sheriff Randall Johnson ably served and protected the citizens of this state as  
28 Fayette County Sheriff with an exceptional career in law enforcement that spanned nearly 49  
29 years; and

30 WHEREAS, born in Fayette County on October 13, 1940, and a graduate of Fayette County  
31 High School, Sheriff Johnson began his law enforcement career in 1959, when he was sworn  
32 in as a Fayette County Deputy Sheriff; and

33 WHEREAS, in 1961, he went to work for the State of Georgia working at the Capitol in  
34 Atlanta, before joining the Georgia Department of Revenue's Division of Alcohol and  
35 Tobacco as a special agent two years later; and

36 WHEREAS, in 1976, he was elected the twenty-third Sheriff of Fayette County and was  
37 successfully reelected by the citizens of Fayette County for eight terms; and

38 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished  
39 Georgian be appropriately recognized by dedicating an intersection in his honor.

41 WHEREAS, Mr. Donald Lyn Seabolt has devoted his life to protecting the safety and  
42 well-being of the citizens of Dahlonega and Lumpkin County and his decades of leadership  
43 and service continue to benefit the community; and

44 WHEREAS, Mr. Seabolt began his distinguished career of public service in 1968 as a  
45 guardian of this nation's freedom and liberty with the 25th Infantry Division of the United  
46 States Army, where he gained the training and discipline that shaped his lifelong  
47 commitment to emergency services; and

48 WHEREAS, in 1972, he became the volunteer fire chief of Lumpkin County and went on to  
49 achieve historic milestones, including becoming the county's first paramedic during a time  
50 when emergency calls were still managed through local funeral homes; and

51 WHEREAS, he served as civil defense director and director of the Dahlonega-Lumpkin  
52 County Emergency Management Agency; and

53 WHEREAS, Mr. Seabolt designed and implemented Lumpkin County's emergency 9-1-1  
54 system, ensuring that emergency assistance could be accessed quickly and reliably through  
55 a modern communications framework; and

56 WHEREAS, his leadership and expertise extended state wide through training emergency  
57 management professionals, serving as president of the Emergency Management Association  
58 of Georgia, earning his emergency management masters certification, and serving on the  
59 State 9-1-1 Advisory Board; and

60 WHEREAS, Mr. Seabolt's more than five decades of service established a lasting foundation  
61 of public safety and community resilience and it is abundantly fitting and proper that this  
62 remarkable and distinguished Georgian be appropriately recognized by dedicating an  
63 intersection in his honor.

65 WHEREAS, our nation's security continues to rely on patriotic men and women who put  
66 their personal lives on hold in order to place themselves in harm's way to protect the  
67 freedoms that all United States citizens cherish; and

68 WHEREAS, Sgt. Major John Barry Dean was born in Aberdeen, Washington, on August 28,  
69 1949, the beloved son of Eddie and Irene Dean; and

70 WHEREAS, he graduated from Arab High School in Arab, Alabama, in 1967, and earned  
71 bachelor's and master's degrees from Embry-Riddle Aeronautical University; and

72 WHEREAS, Sgt. Major Dean served as a guardian of this nation's freedom and liberty with  
73 the United States Marine Corps and honorably served this nation for 36 years as an avionics  
74 technician until his retirement as the Sergeant Major of the 24th Marine Regiment in 2004;  
75 and

76 WHEREAS, his professional career included work with Boeing, Martin Marietta, Rockwell,  
77 and Lockheed Martin, where he served as a quality engineer in the F-22 Raptor program; and

78 WHEREAS, Sgt. Major Dean was elected to the Paulding County School Board in 2018 and  
79 served over six years with enthusiasm and a deep love for the students, staff, and schools he  
80 represented; and

81 WHEREAS, he embodied the spirit of service and willingness to find meaning in something  
82 greater than himself, and it is abundantly fitting and proper that this remarkable and  
83 distinguished Georgian be recognized appropriately by dedicating an intersection in his  
84 memory.

#### **PART V**

86 WHEREAS, correctional officers Christopher Monica and Curtis Billue were highly  
87 regarded by the citizens of their community and state and by local government officials as  
88 persons of unquestioned integrity and dedication to the sound principles of law enforcement;  
89 and

90 WHEREAS, Sergeant Monica began his career with the Georgia Department of Corrections  
91 in October, 2009, as a correctional officer at Hancock State Prison before serving as a  
92 sergeant with Baldwin State Prison, the transportation unit, and Augusta State Medical  
93 Prison; and

94 WHEREAS, Sergeant Billue began his career with the Georgia Department of Corrections  
95 in July, 2007, as a correctional officer at the Frank Scott Correctional Facility before serving  
96 at the Georgia Diagnostic Classification Prison, Baldwin State Prison, and with the  
97 transportation unit; and

98 WHEREAS, Sergeant Monica and Sergeant Billue diligently and conscientiously devoted  
99 innumerable hours of their time, talents, and energy toward the betterment of their  
100 communities and state; and

101 WHEREAS, their lives were tragically cut short in the line of duty when they were shot and  
102 killed by two inmates who escaped during transport; and

103 WHEREAS, Sergeant Monica and Sergeant Billue exhibited extraordinary devotion to public  
104 service, outstanding loyalty, fine leadership, and meticulous attention to detail in all of their  
105 duties and it is abundantly fitting and proper that these remarkable and distinguished  
106 Georgians be recognized appropriately by dedicating a road in their memory.

108 WHEREAS, Mr. Richard Keith "Rick" Worley devoted his life and career to the community  
109 of Catoosa County and Ringgold, Georgia; and

110 WHEREAS, a native of Catoosa County and cornerstone to his community, Mr. Worley  
111 graduated from Ringgold High School and successfully owned and operated the Rick Worley  
112 and Son Autobody shop; and

113 WHEREAS, after the tragic passing of his son in 2010, Mr. Worley established the Hunter  
114 Worley Foundation which assists grieving parents in North Georgia and Tennessee Valley  
115 with funeral and burial expenses; and

116 WHEREAS, Mr. Worley gave selflessly to his local community through his work sponsoring  
117 numerous fundraising efforts at Graysville Elementary School and local middle and high  
118 schools in Catoosa County; and

119 WHEREAS, he provided professional services to local police and fire departments and  
120 frequently donated equipment and drivers for community parades; and

121 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished  
122 Georgian be appropriately recognized by dedicating an intersection in his memory.

124 WHEREAS, United States Treasurer Brandon L. Beach has long been recognized by the  
125 citizens of this state for the vital role that he has played in leadership and his deep personal  
126 commitment to the welfare of the citizens of Georgia; and

127 WHEREAS, he served the people of Georgia with distinction for over two decades, having  
128 been elected to the Georgia State Senate in 2013 representing District 21; and

129 WHEREAS, Treasurer Beach held several influential positions in the Senate, including  
130 Chairman of the Senate Transportation Committee, where he was instrumental in advancing  
131 transportation and infrastructure reforms critical to Georgia's economic growth and global  
132 competitiveness, and Chairman of the Senate Economic Development and Tourism  
133 Committee, where he focused on fostering a business friendly environment in this state; and

134 WHEREAS, Treasurer Beach served as the executive director and founder of the North  
135 Fulton Improvement District and has held key leadership roles with the Georgia Regional  
136 Transportation Authority, the Georgia Department of Transportation, and the Fulton County  
137 Development Authority; and

138 WHEREAS, he was appointed by President Donald J. Trump to serve as the United States  
139 Treasurer, a role in which he oversees the nation's financial operations, manages the U.S.  
140 Mint and Fort Knox, and advises on matters of fiscal policy; and

141 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished  
142 Georgian be recognized appropriately by dedicating a road in his honor.

144 WHEREAS, Ms. Abigail Savoie grew up in Fayette County, Georgia, playing soccer,  
145 cheerleading, swimming, and running; and

146 WHEREAS, she attended Georgia College & State University in Milledgeville, which she  
147 affectionately referred to as "Milli," and was an active member of Alpha Gamma Delta  
148 Sorority; and

149 WHEREAS, Ms. Savoie studied public health and had hopes of joining the Center for  
150 Disease Control upon graduation, where she could put her compassion and heart into helping  
151 others; and

152 WHEREAS, she was a people person who cared for the well-being of other people, always  
153 the first to help out another in need; and

154 WHEREAS, Ms. Savoie's life was tragically cut short on October 21, 2022, when returning  
155 to school, her vehicle was struck at the intersection of GA 16 and High Falls Road and  
156 England Chapel Road near Jackson, Georgia, by a driver who ran a stop sign; and

157 WHEREAS, although the loss of this smart, energetic, and beautiful soul can never be filled,  
158 her death called attention to the other numerous accidents at the intersection where her  
159 vehicle was struck, and resulted in plans to convert the intersection into a safer roundabout,  
160 likely saving the lives of other motorists; and

161 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished  
162 Georgian be recognized appropriately by dedicating a roundabout in her memory.

### **PART IX**

164 WHEREAS, Dr. James Larry Boss has long been recognized by the citizens of this state for  
165 the vital role that he has played in leadership and his deep personal commitment to the  
166 welfare of the citizens of Georgia; and

167 WHEREAS, Dr. Boss was born to a sharecropper during the Great Depression and graduated  
168 from McDonough High School, where he was an outstanding football player; and

169 WHEREAS, a graduate of Emory University and Medical College of Georgia, Dr. Boss  
170 served as a guardian of this nation's freedom and liberty as a flight surgeon with the United  
171 States Air Force; and

172 WHEREAS, Dr. Boss has been a devoted and dedicated fan of Villa Rica High School's  
173 football program and served as the Wildcats team physician providing aid to injured players  
174 and fans for decades; and

175 WHEREAS, his leadership and guidance have been instrumental on numerous boards and  
176 organizations, including the Villa Rica City Ethics Board, Bank of Villa Rica, Regions Bank,  
177 and the Rapha Clinic; and

178 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished  
179 Georgian be recognized appropriately by dedicating a road in his honor.

181 WHEREAS, former State Representative "Able" Mable Thomas was a fearless activist and  
182 legislator whose life and legacy were deeply rooted in Atlanta's Vine City community, where  
183 she was born, raised, and later called to serve with unwavering dedication; and

184 WHEREAS, shaped by Vine City's central role in Atlanta's civil rights history,  
185 Representative Thomas carried forward the neighborhood's tradition of resistance,  
186 organizing, and community leadership in her lifelong fight for racial justice, equity, and  
187 Black political empowerment; and

188 WHEREAS, throughout her service in the Georgia House of Representatives, Representative  
189 Thomas remained firmly grounded in Vine City, using her platform to speak truth to power  
190 and advocate relentlessly for the residents and working families of her community; and

191 WHEREAS, renaming this intersection in honor of Representative "Able" Mable Thomas  
192 permanently recognizes her profound impact on Vine City and Atlanta, ensuring that the  
193 legacy of a daughter of the community who became its champion is etched into the very  
194 streets she fought to uplift; and

195 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished  
196 Georgian be appropriately recognized by dedicating an intersection in her honor.

198 WHEREAS, Mr. Jerry Hoy has long been recognized by the citizens of this state for the vital  
199 role that he has played in leadership and his deep personal commitment to the welfare of the  
200 citizens of Georgia; and

202 Association in Atlanta, Georgia, and was a central figure in the neighborhood's early

205 hosting planning sessions and helping to shape the zoning, design guidelines, and community  
206 vision that laid the foundation for the modern Castleberry Hill Historic District; and

207 WHEREAS, Mr. Hoy's leadership was pivotal during the neighborhood's transition from  
208 decades of industrial decline into the vibrant residential and arts community it is today; and

209 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished  
210 American be recognized appropriately by dedicating a road in his memory.

212 WHEREAS, Mr. Jim S. Briscoe has long been recognized by the citizens of this state for the  
213 vital role that he played in leadership and his deep personal commitment to the welfare of the  
214 citizens of Walton County, Georgia; and

215 WHEREAS, born in Between, Georgia, Mr. Briscoe was raised on his family's farm and  
216 graduated from Monroe High School; and

217 WHEREAS, he served as a guardian of this nation's freedom and liberty in the United States  
218 Navy, serving as a machinist in the engine room of a minesweeper during World War II; and

219 WHEREAS, upon completion of his service to this nation, Mr. Briscoe returned to Between  
220 to work on the family farm before his employment with DuPont as a maintenance electrician;  
221 and

222 WHEREAS, Mr. Briscoe made history as the first mayor of Between with his election in  
223 1970; and

224 WHEREAS, Mr. Briscoe served with honor and distinction as the mayor of Between and his  
225 vision and unyielding commitment set the standard for public service; and

226 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished  
227 Georgian be recognized appropriately by dedicating an intersection in his memory.

236 he served as a foreman for 37 years; and

237 WHEREAS, a man of deep and abiding faith, Mr. McGhee was a long time member of the

253 gentleman be recognized appropriately by dedicating a road in his memory.

264 struck from behind by a motorist while cycling on the outskirts of Sandersville; and

265 WHEREAS, he was a person of magnanimous strengths with an unimpeachable reputation  
266 for integrity, intelligence, fairness, and kindness, and by the example he made of his life, he  
267 made this world a better place in which to live; and

268 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished

285 abundantly fitting and proper that this remarkable and distinguished Georgian be
